## A RESOLUTION AMENDING RESOLUTION #09-08, CONFIRMING THE NOMINATION OF DAN AGENT AS AN EDITORIAL BOARD MEMBER OF THE CHEROKEE PHOENIX

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Free and Independent Press for the Cherokee Nation, Editorial Board was created and authorized by Legislative Act 11-00;

WHEREAS, Dan Agent is nominated by the Principal Chief to serve a term as an Editorial Board Member of the Cherokee Phoenix effective January 2008 through October 2011, as authorized by Legislative Act 11-00;

WHEREAS, Dan Agent is duly qualified to fill this vacancy pursuant to the laws of the Cherokee Nation.

**BE IT RESOLVED BY THE CHEROKEE NATION,** that Dan Agent is hereby confirmed as a Board Member of the Editorial Board of the Cherokee Phoenix for a term effective January, 2008 through -October, 2011 as authorized by Legislative Act 11-00, the Act of July 17, 2000.
