#### Program Highlights for January 2011

- I. Office of Veterans Affairs: The Tribal Veteran's Representative received 44 calls for services in January. He also met with 76 veterans in person and had 1387 outreach with other providers. This includes the Pre-Mobilization Meeting with the 45<sup>th</sup> Brigade of the National Guard, conducted by the DOD, and the Tulsa Vet Center. (Readjustment Counselor)
- 2. Healing to Wellness Court Program: 4 youth are participating in the voluntary Reclaiming Futures program. There were 4 participants, I was from Sequoyah High School, client is out of the age range of the program, however we are helping her with case management services. There were I I home visits. January 4 we met with Delaware County Court Officials to discuss moving forward on referring youth to the Healing to Wellness Court.
- 3. Bright Futures (Truancy Prevention): The Bright Futures program is serving 16 youth in the month of January. It has demonstrated improvement in attendance. We have served 15 families through referral, information, etc. (may not have agreed to service). Two students from Westville who had severe truancy problems last year attended court and the Judge praised them for their excellent attendance record this year.
- 4. Child Care & Development: We had 228 resource and referral calls for January. 315 providers in training. 3 community play groups that served 35 children and 26 adults. Dr. Stuart Shanker presented training for Child Care Providers and Cherokee Nation employees on Brain Development. Marsha White and Phyllis Yargee participated with the JOM Program in Cherokee Cultural Curriculum Development and provided input for Early Childhood and Age Appropriate activities that will be included in a final curriculum later this year.
- 5. ICW Child Protective Services (CPS): There were 99 referrals. Of these, 4 were on Indian Country. All of them were for neglect. Three have been ruled out and one is ongoing. There were 42 Families First referrals. There were 2 conjoint investigations conducted with Delaware County. There was one child placed in a C.N. Foster home.
- 6. ICW Court Advocacy and Permanency (CAPS) Units: There are 536 Cherokee children with assigned ICW workers. ICW workers were in court 83 times in December. These children and cases are from the Tribal, State, and Out-Of-District Units.
- 7. ICW Mayes County Prevention Program: The MCPP provided services to 55 children and 38 adults in January. 26 families received services. More than 800 people attended group parenting services.
- 8. John Ketcher Youth Shelter: 16 youth spent time at the John Ketcher Youth Shelter in January. 11 were new admissions and 5 were carried over from December. Out of 16 youth 16 were successfully placed back in the home or remained in home/safe placements.
- 9. Juvenile First Time Offender program. 8 carried over from December. 6 sessions to a total of 7 participants. I successful completion, 18 hours of Community Services by 3 participant s. I referral. 7 expected to complete in January.

- 10. Family Assistance (Food Distribution): 9,478 served this month.
- II. Family Assistance (Elderly Nutrition): 2,254 hot meals were served at Elderly Nutrition Sites
- 12. Family Assistance (LIHEAP): 665 households served for heating assistance.
- 13. Child Support Services: Distribution for December was 201,870.00. There is a total of 2,700 child support cases. Clothing Voucher update: Placed a request for bids to determine the optimum merchant for this year's program to utilize. The ideal merchant will be accessible to all citizens in the jurisdictional boundaries of Cherokee Nation. The locations include, Tahlequah, Nowata, Ft. Gibson area, Jay, Stilwell, Ramona, Sallisaw, Gore, and Claremore area. Continued information will be forthcoming as things are secured.
- **14. Success Stories**: a family with a special needs child, after receiving multiple services (including home management skills) was able to purchase a mobile home. The MCPP worker assisted the self-referred with the process and they were most appreciative. In fact, they wrote a letter to MCPP expressing their gratitude.

- Processed 64 youth applications, 45 adult applications

• Twenty-nine sub award proposals have been reviewed

#### **Community Buildings**

- Brent Community Building—safe room completed and exterior walls being installed. 15% complete
- Rocky Mountain Community Building—interior walls are being erected, rough-in plumbing and electric has begun. 40% complete
- D.D. Etchieson Community Building—slab is complete, metal being installed, building should be dried in before the end of the month. 25% complete
- Vian Community Building—dried in and most first floor framing has been completed; preparing to run three phase service to the building. 40% complete
- Cherokee Elder's Rainbow House—near completion of dried in stage, metal should be complete before the end of the month. 20% complete
- Lyons Community Building—sheetrock complete with the exception of the ceiling in the common area, installation of cabinets and fixtures to begin soon. CNE donated old restaurant lobby cabinets and countertops to the community building. 75% complete
- Eucha Community Building—most interior work complete, cabinets and countertops to be installed. Working with PSO to run service from pole to building. 90% complete
- Kenwood Community Building—porch overhangs, exterior trim painting, landscaping and signage still remaining. Minor interior touch-ups and hardware to be completed very soon. 97% complete

- Jay/Kenwood Road—Environmental assessment is underway. MOU between Delaware County and the Nation is in place to coordinate with the county engineer for bridge design and construction
- Twin Oaks/Bull Hollow Road—Plans and Right of Way acquisition is complete. NEO Electric is acquiring Right of Way for utility relocation. Telephone relocation is 50% complete

#### **Mayes County Projects:**

- Cedar Crest Road—The Roads Program and Fairpoint Communications are negotiating language on MOA and MOA attachments for the telephone relocation
- Cedar Crest Bridge—All utilities have been relocated with the exception of a waterline and telephone. Agreement with Fairpoint Communication (telephone) is expected to be executed in December
- Salina/Kenwood Road—MOU between Mayes County and the Nation is in place to coordinate with the county engineer for Wickliffe bridge design and construction

#### **Muskogee County Projects:**

• Northeast Fort Gibson—In right of way process; right of way acquisition meeting is tentatively scheduled for April 14, 2011. Location and time undetermined at this time

## b. Notable accomplishments

Program to date, 297 families unable to obtain a non-predatory mortgage on their own have completed self-sufficiency counseling and obtained a non-predatory mortgage.

- YTD, Self Sufficiency Staff are currently working with 15 clients facing foreclosure. All of these families are still in the process of trying to save their homes.
- Self Sufficiency staff met with 85 lenders and realtors in Tahlequah, Sallisaw, Jay, Bartlesville and Claremore to provide an opportunity for them to learn and ask questions about MAP.
- Self Sufficiency staff are coordinating the Volunteer Income Tax Assistance (VITA) Program again this year. Volunteers are providing free tax preparation and electronic filing for taxpayers in multiple locations throughout Cherokee Nation's jurisdiction. We have submitted over 1,127 returns year to date and have received over \$2 million in refunds with over \$747,000 for Earned Income Tax Credit.

d. Foreclosure information: Tulsa is currently ranked 6<sup>th</sup> on the list of cities with the fastest growing rate of foreclosures. Fortunately for Tulsa, the foreclosures are being purchased quickly; in other parts of the country that have been hard hit in the foreclosure crisis, the impact is much more severe because there are no buyers to purchase the housing over stock. According to an economist with the Tulsa Metro Chamber, the economy is still doing pretty well and they anticipate 2-3% job growth in 2011.
