





#### **Real Estate Services**

The Office of Real Estate Services is responsible for administering the laws, regulations, and policies affecting the protection and management of trust and restricted lands of individual Indian landowners and the land owned by the Cherokee Nation itself, located within the 14 county area of the Cherokee Nation. Real Estate Services operates under a Self-Governance Compact with the Secretary of the Interior.

#### II. Program Highlights:

- 1. <u>Purchases</u>. One purchase was made during the month of December, located in Tulsa County.
- 2. <u>Appraisals</u>. Seven appraisals were ordered; one approved by BIA.

- 3. Quiet <u>Title Notices</u>. Four quiet title notices were received from the Solicitor's office, researched and returned.
- 4. <u>Leases.</u> One new Restricted hunting leased was submitted; two are pending and one was approved during the month.
- 5. <u>Last Will & Testaments</u>. Eight LW&T interviews were taken and eight drafts prepared.
- 6. <u>Inventory/Heirships</u>. Four inventory/heirships were requested and returned.
- 7. Report for Distribution/IIM Set-ups. Six RFDs were requested, researched and submitted to BIA; eight IIM setups were completed.
- 8. Rights of Entry. 15 rights of entry were requested and completed.
- 9. <u>Rights of Way/Easements</u>. Nine trust/restricted rights of way are pending. Two fee rights of way have been submitted and two were approved.
- 10. Service Line Agreements. One pending; one approved.
- 11. On-Site Inspections/Home visits. 34 on-site inspections were requested and completed.
- 12. Maps/platting. 32 requests for maps/platting assistance were received and completed.
- 13. Land status calls. 26 land status verification calls were completed during the month.
- 14. <u>Financial transactions</u>. During the month of December, \$110,855.73 was processed as lease payments and \$244.227.26 was processed through lockbox.
- 15. <u>District Court Probates.</u> All new probate applications are being researched in preparation for filing in District Court.
- 16. Research. Two staffers continue performing multi-county research.
- 17. <u>TAAMS</u>. Coordinating with EORO to get files encoded, additional staff being processed for TAAMS computer and accessibility. Currently, three staffers are performing final review and updates.
- 18. Stats. 30 client sign-ins; 50 phone inquiries; 41 obituaries were processed.

The Dahlonegah crew have continued to work on fencing, cutting wood and brush hogging properties along with their maintenance of the equipment. Bull hollow crew have been working on the additional fencing project, along with cutting wood and brush hogging properties. They are also still mowing other Cherokee nation owned properties and feeding our buffalo. Tahlequah crew have been brush hogging properties, feeding cattle, and building fence. We have sold 44 head of calves in the month of November. We have approximately 200 head of momma cows and approximately 150 baby calves, we have 133 cows in the feed lot and 45 big steers and heifers in another feed lot. We also have approximately 350 head of buffalo that are having baby calves currently. Our department has three jobs out on bid at this time and we are just waiting for them to be completed that will help our cattle operation run more efficiently.

• The final litterfall samples were collected on December 5; the litterfall collectors were set up near Dahlonegah School in September and remained in place for duration of the fall season. The samples will be analyzed for mercury by the National Atmospheric Deposition Program (NADP).

The AQLite monitor will be deployed at the Stilwell air monitoring site in late December.
- Staff is reviewing the 3rd quarter air monitoring data in preparation for entering the data into the EPA Air Quality System (AQS); the data will be submitted prior to December 31.

- Staff has been working with Windsor Solutions to load radon data records into the CDC RAD (rapid address identifier) tool and TAMU (Texas A&M University) GeoServices and get back the proper geocoding results. A no-cost extension from EPA Region 6 has been approved to extend the grant another year; the award letter has been received. Staff is waiting on the contract with Windsor to be signed by management.

In this capacity, CNEP provides technical assistance, data analysis, multi-media sampling, and training opportunities to the 44 member tribes. NOTE: *CN Programs* - are programs that serve the Cherokee Nation. *ITEC Programs* - are programs that serve both the Cherokee Nation and the other 44 ITEC tribes. U.S. EPA Region 6 consists of the following states – Oklahoma, New Mexico, Texas, Louisiana, and Arkansas.

#### ITEC Underground Storage Tanks Program (UST):

• Staff assisted the Clean Water program with sampling.
