


## **Community Youth Applications** by County

# Programs with Court Interaction

## **OCAPS: Out-Of-District Court Advocacy and Permanency Services**

- Involved in child welfare cases in non-jurisdiction counties in Oklahoma and all 50 states.
- Most work is done telephonically or electronically.
- Emphasis on education about the Indian Child Welfare Act and ensuring States comply with it.

## SCAPS: State Court Advocacy and Permanency Services

- Involved in child welfare cases inside the 14 counties of which all or part are within the jurisdiction of the Nation.
- Emphasis on education about the Indian Child Welfare Act and ensuring OKDHS compliance, and sometimes provide Tribal Foster Homes.
- Provides services to the families when OKDHS fails to do so or as an alternative to OK DHS services.

## **TCAPS: Tribal Court Advocacy and Permanency Services**

- Involved in child welfare cases which are wholly under the jurisdiction of the Nation and OKDHS is not involved.
- These cases originate on Indian Country or are transferred in from State district courts. Hearings are held at our Tribal Court House. Tribal Foster Homes are fully utilized.


## **GPA:** Guardianships and Private Adoptions

- Involved in civil adoption cases to include voluntary adoption, involuntary adoption and birth parent adoptions.
- Monitors Guardianships and Private Adoptions for compliance with the Indian Child Welfare Act and the best interests of children.
- Serves Cherokee children and their families in Tribal Courts and State Courts throughout the United States.

#### **CPS: Child Protective Services**

- Receives referrals involving allegations of maltreatment of Cherokee children.
- Investigates allegations of child maltreatment in Indian Country and co-investigates with DHS in some counties when Cherokee children are involved.



## In May

Indian Child Welfare workers went to court 486 times on behalf of Cherokee children and families. Indian Child Welfare staff worked on cases in 31 states.

# Eligibility Notices, Prevention, & Intervention

When a county or state's child welfare agency gets involved in the life of a family that they suspect to be Cherokee, they are required by the Indian Child Welfare Act (ICWA) to send notice to the tribe. The tribe must then reply to confirm or deny whether the children are members of (or eligible to become members of) the tribe.

Currently, with 6 case workers processing approximately 200-300 pieces of mail per month, response times may vary due to vacancies and depending on the amount of mail received. The tribe has a goal of responding between 45-60 days.

### In May

Cherokee Nation received:

595 notices involving 1,052 children from the State of Oklahoma.

834 notices involving 1,332 children from locations outside of Oklahoma.

1,429 notices involving 2,384 children in total.

The average response-to-notice time this month was 101 days.

Indian Child Welfare Family Protection Services Unit (FPS) assists families in need of handson training to correct the conditions that lead to children being removed from their home.
These services often include completing a 28-week parenting program that discusses topics
like discipline, nutrition, budgeting, and housekeeping. We primarily assist all our tribal CAPS
cases but can assist in state cases when a request is made. This helps ensure that families
have the tools they need to be reunited. We have also added the Triple P Parenting
curriculum to our program.

FPS served 16 children and 11 families.

## In May

Child Protective Services (CPS) received 475 referrals of child abuse/neglect.


475 referrals involved 842 children.

2 of the 475 were co-investigated by OKDHS and CPS.

10 of the 475 were investigated by CPS in Indian Country.

3 Cherokee child(ren) were removed from tribal land due to confirmed abuse/neglect.

# Types of Abuse/Neglect Reported





# Types of Certified Placement Resource Homes

- Non-Relative Foster: Families who are willing to take in children they do not know on a temporary basis, but may last years. These families usually do not adopt children.
- •Relative Foster: Families who are related to the children and are fostering them. They do not take in children they are not related to.
- •Non-Relative Adoptive: Families who hope to adopt children when the children's parents' rights are terminated. These homes take placements of children who are legally free for adoption.
- Emergency: Homes that take placement on an emergency basis not to exceed 48 hours.
- •Respite: Homes that take placement on a temporary basis, not to exceed 10 days.




## **Total Applications Received**




## **Court Docket Appearances**

## Department Updates

The Office of Child Support Services reports the following: The office is maintaining normal office hour operations with all staff regularly reporting to offices. There are 32 current filled staff with 5 open positions: 1 clerical, 1 for a customer service rep, 1 legal filing clerk and 2 child support specialist positions. The program has submitted recommendations for hire for all the vacancies so hope to report that all positions will be filled soon.

The program staff are always available to be reached by phone at 918-453-5444 or email at childsupport1@cherokee.org for any visitors/ client questions. The program has full time staff to assist with child support matters in the Catoosa, Pryor, and Sallisaw Human Services office.

With the opening of the new office in Stilwell, the program is working towards having a full time employee there by the end of 2021. In the meantime, the program does have a staff person there every Wednesday. The program distributed 57 applications via walk in's, mail outs, email, or downloaded through our child support website and received 67 new applications for services in April. The program's website address: https://childsupport.cherokee.org has continued to see regular activity on their website page and in April there were 3,861 unique views to the child support website page.

Current active cases as of June 15, 2021-2,434. The program is finalizing the Digital Marketing Grant initiatives by finalizing the data collection results of the text message services certain staff are utilizing through the Digital Marketing Grant program to see if it makes an impact on improved communication between the parties and the office.

The program continues to have success stories due to the great work of the front line staff! One of the case manager's reported on successfully working on an agreed order between two parties that will assist the obligor the ability to pay regularly for all 3 of their cases; another case manager reported successful agreed modification order between parties; another case manager reported having an obligor worked to pay off all balances while caring for his children; finally a case manager who carries a tribal court caseload reported a majority of her obligors are gradually returning back to work. Additional assistance the Child support Team has provided is the various phone calls that have been received by the staff to help potential citizens regarding accessing the ga du gi portal and letting our families know about assistance through Cherokee Nation. It has been a busy time and also very rewarding time working for Cherokee Nation.







# Service Spotlight

This newsletter is intended to provide a spotlight on a service recently provided through the Cherokee Nation Engineering & Sanitation Facilities Construction program.

Ms. Marjorie LeGates lives in Rogers County in the Talala Community. She applied to the Sanitation Facilities Construction program in 2018 for water and sewer services for an existing mobile home. Due to the poor condition of the original mobile home we referred her to the Housing program. In November 2020 Ms. LeGates notified us that a newer mobile home had been obtained and moved on-site. A site evaluation was completed in December 2020. A soil test was completed in early February 2021. The home was ready for services and a PO issued to Jerry's Excavation to install the services in March 2021. Due to the requirements of the rural water district we had to enter into an agreement with them to bore under the road way and install the water meter. Due to the proximity of a high pressure gas line an on-site meeting was held in May 2021 to discuss the excavation and ensure the safety of all parties. Services were finally installed on May 25, 2021.

Some sites do not have enough room to space out participants 6 ft. apart, also scissors, glue, markers and other supplies and equipment have to be shared by participants and staff, a lot of our activities are very hands on and several of our participants have to have one on one instruction and help, a lot of our participants at our adult sites have a hard time hearing us anyway and wearing a mask would make it even more difficult for them to hear and most of our projects can't be done with gloves on, therefore we felt it would be in the best interest of our participants for their health and safety to cancel activities for May.

Staff sent out small puzzle books to all elder and youth participants we have good addresses for. We are hoping this will help our elder and youth participants feel less isolated and let them know they aren't forgotten. Made and sent out 148 puzzle books.

Staff are also working on organizing supplies, learning new skills to use at activities, watching on-line webinars and trainings to help us in future activities and looking for & working on new projects and presentations. We also have been packing stuff to move the offices. Some staff watched a virtual training on twinning by Matt Anderson from the Spider Gallery and Cherokee Art Center and learned to twine and are working on perfecting the skills and learning all the techniques so we can teach participants in the future.

I am still receiving messages from several of our adult participants saying they really appreciate the postcards & puzzle books.

### ADAIR COUNTY PROJECTS:

1. Dahlonegah South (TCM Dist. 7) – Estimated project cost is \$5,108,775. Waiting for Real Estate Services to prepare a transmittal to the BIA for approval of all trust and restricted parcels. Cherry Tree RWD relocation is complete.

## CHEROKEE COUNTY PROJECTS:

- 1. Northeast Fort Gibson Phase I (TCM Dist. 1 & 4) Estimated project cost is \$14,875,141. Construction of Phase I is 97% complete. There is no change to this project. The contractor is being charged \$1,000.00 per day Liquidated Damages.
- 2. Hulbert Lost City Road (TCM Dist. 1) Estimated project cost is \$5,309,853. Placing concrete structures has started. The project is 15% complete.
- 3. Mud Valley (TCM Dist. 1 &3) Estimated project cost is \$14,432,000. There are a total of 77 parcels. Thirty-three parcels have been acquired and 75 offer packets have been given.

#### CRAIG COUNTY PROJECTS:

- 1. NS4340 also known as White Oak road (TCM Dist. 11) Estimated project cost is \$9,442,834. This project is 60% complete with the contractor constructing the reinforced concreted box extentions and placing sod and rip rap on section I. They are placing aggregate base and working on the subgrade, placing fabric on the north end of the project.
- 2. NS4410 Road (TCM Dist. 11) Estimated project cost is \$5,597,000. Craig County RWD 2 has a contractor beginning the waterline relocation. The anticipated completion for this waterline relocation is September 2021.

## **SEQUOYAH COUNTY PROJECTS:**

1. Dwight Mission Road (TCM Dist 5) – Estimated project cost is \$10,263,728. This is a cooperative project between ODOT, Sequoyah County and CNDOT. This project is appoximatly 55 % complete. A detour has been constructed, along with drainage structures, erosion control, and widening of shoulders. Solid Slab Sod has been laid as well.

#### CHEROKEE TRANSIT SYSTEM:

The Cherokee Nation Transit received 4 of 6 vans purchased through CARES, an FTA Discretionary Grant, and Tribal match funds. These vans will serve 1 commuter route and 5 will provide Demand Response services in Tahlequah, Stilwell, Vinita, and Muskogee and Washinton County areas. The remaining two vans are expected in 2-3 weeks.








