
CNHS Provider Vacancy Rate



IHS Provider Vacancy Rate Benchmark








Monthly Visits by Location








YTD CHS Spend by Location







Patient Visits and Revenue



Part A: PUBLIC HEALTH LEADERSHIP

Public Health Accreditation Board (PHAB) Reaccreditation: December 2021:

- Update Cherokee Nation Public Health core documents to ensure competency with the 2020 updated Ten Essential Services of Public Health and PHAB Standards and Measures Version 1.5
- Public Health Strategic Plan –completed and approved
- PHAB domain re-accreditation documentation ongoing uploading documents and narratives for each domain
- Tribal Health Assessment final draft stage; reviewing report with community groups and internal partners; working with CN Communications to develop branding
- Tribal Health Improvement Plan pending completion of THA
- Public Health Performance Management training/implementation of PM software with Conduit; remains in the contract process
- Public Health Workforce Development PH workforce inventory completed, PH workforce survey completed, competency analysis in progress

Cross-Collaborative with CN Education:

• Team has expanded to include staff other CN divisions. Have selected framework to develop the Social Determinants of Health Accelerator met with selected facilitator from Clear Impact. The model we are using is the Results Based Accountability (RBA) method. Our team will start working with the facilitator in January of 2022.

Centers for Disease Control and Prevention (CDC) Tribal Advisory Committee (TAC):

Continued work with assessment of tribal-specific work by CDC Centers, Institutes, and Offices (CIOs).
 Deputy Chief Bryan Warner was elected Chair of the CDC TAC and designated Cherokee Nation Senior Director of Public Health as his Authorized Representative. TAC charter has been revised and reviewed multiple times and is near completion.

National Association of City County Health Officials (NACCHO):

Cherokee Nation Health Services Senior Director of Public Health was elected to the Board of Directors representing Tribal Public Health Departments. NACCHO is the only organization dedicated to serving every local health department in the nation. NACCHO serves 3000 local health departments and is the leader in providing cutting-edge, skill-building, professional resources and programs, seeking health equity, and supporting effective local public health practice and systems.

Public Health Monitoring & Surveillance:

- Beginning early implementation of the Conduent community data dashboard program
- 2 meetings with school superintendents to support their COVID mitigation and response plans

- Overall COVID-19 Response Efforts The entire Epi Team works in both contact tracing efforts as well
 as surveillance efforts. The nursing staff on our team regularly support vaccination efforts, for both
 COVID and influenza.
- County Health Assessments: being completed during November 22021
- Opioid Overdose Prevention: Focusing on a comprehensive surveillance system for opioid addiction, overdose, and death.
- Youth Risk Behavioral Survey (YRBS): This dataset helps us determine the health behaviors (risky behaviors) that high school students engage in. This helps support our public health programs and helps to determine if they are effective. 14 of 18 selected schools have agreed to participate, 1 school is considering, and 3 schools have declined the opportunity. ACEs: Building ACEs Surveillance Capacity with the Cherokee Nation. The purpose of this project is to increase the capacity of Cherokee Nation Public Health to assess, collect, and analyze Adverse Childhood Experiences (ACEs) and Positive Childhood Experiences (PCEs) data in order to develop effective and data driven public health strategies to reduce ACEs and promote PCEs within Cherokee Nation.

 - P20 Research: Feasibility Studies to Build Collaborative Partnerships in Cancer Research (P20). The collaborative between Cherokee Nation and the University of Oklahoma Stephenson Cancer Center aims to create the capacity to address tobacco-related cancer disparities in Cherokee Nation through a linked program of pilot research and training/education for new investigators and students committed to advancing this work. Dr. Comiford is the pilot lead on the Project Titled "Electronic Cigarette Use among Pregnant American Indian Women. Dr. Garrett is the pilot lead on the project involving smoking cessation
 - Support for Creative Integrated Basic and Applied Research (SCIBAR) grant from Johns
 Hopkins University Center for American Indian Health. Dr. Garret is the lead on this project
 focusing and community based participatory research in estimating the prevalence of injection
 drug use in Sequoyah County. This project is still in the preliminary phases of development and
 is progressing.
 - Hepatitis C Elimination Program Dr. Gahn is the epidemiology lead on this project offering epidemiologic support to the Infectious Diseases Department. We are also planning to expand into providing contact tracing for the GHOST program.
