The Cherokee Nation Gaming Commission Commissioners held a Commission Meeting on November 18, 2021.

During the meeting the Cherokee Nation Gaming Commission issued sixty-three (63) Individual(s) for Temporary Permits

Forty-four (44) Individual(s) for Suitability Determinations

Forty (40) License Order and One hundred and two (102) Renewals for approval. (Employee Licensing)

the Cherokee Nation Gaming Commission eighteen (18) Individuals orders, seven (7) Company Renewals, forty-nine (49) Individual Renewals (Vendor and Vendor Representative Licensing)

The Licensing Department of the CNGC performs background checks of the potential employee or employee for a Gaming License before the applicants (employee and vendor) are presented to the Commissioners for a vote at the Gaming Commission Meeting.

Cherokee Nation Gaming Commission approved the following new electronic themes, new gaming cabinets, new main programs, new gaming components. The Cherokee Nation Gaming Commission also affirmed Executive Director Approval items.

#### Electronic Game Themes:

The Compliance Department presented 17 new electronic game themes, 4 new OS/main programs, 1 new game component, 2 new gaming cabinets and 5 items that received Executive Director Approval.

The Compliance Department also presented a review of System of Internal Control Standards (SICS) which was submitted for review by CNE. The Commission voted to approve the SICS revision in accordance with Tribal Internal Control Standards (TICS) Section 2.1 (C).

The Audit Department presented an update for the Audit Department. The Audit Department has completed the 20-21 Audits and is working on Audits for FYI 2022.

CNGC Compliance staff have been inspecting the Cherokee Nation Casino properties for the issuance of Facility license(s) which need to be submitted to NIGC by December 31, 2021, renewals

#### II. Program Highlights

#### a. Tribal Transportation Self-Governance Program

On June 9, Cherokee Nation received notice that we were deemed eligible to participate in the U.S. Department of Transportation's Tribal Transportation Self-Governance Program. The goal of the Tribal Transportation Self-Governance Program is to offer greater control, flexibility, and decision-making authority over federal funds used to carry out tribal transportation programs, functions, services, and activities (PFSAs) in tribal communities. Since the June 9 determination, Cherokee Nation's negotiating team has worked diligently to draft a compact and funding agreement. We recently met face-to-face, via Zoom, with the Department of Transportation's designated negotiator, and we are making progress towards a final compact and funding agreement.

#### b. Public Law 102-477 Updates

Public Law 102-477 allows tribes to seamlessly integrate federal employment, training, and related services to maximize efficiency and ensure our tribal citizens receive as many services as possible. We are currently working across departments to ensure everyone is coordinated in our efforts. In mid-August, we received notification of approval on a Plan Amendment related to childcare. In late November, we received approval from the Bureau of Indian Affairs Division of Workforce Development on an additional amendment. We appreciate the coordination and efforts of Cherokee Nation staff that has resulted in positive outcomes for our P.L. 102-477 initiatives.

We are also working to maximize our opportunities in this space, and we continue to engage our federal partners and other tribes to learn from their work.

#### c. Reports

Cherokee Nation departments are working diligently on our annual P.L. 102-477 narrative and financial report. The report includes three components. We will submit this report in the coming weeks. We continue to track our reports closely and submit them when the Bureau of Indian Affairs Division of Workforce Development and the Office of Self Governance request them.

#### d. Funding Updates

To date, Cherokee Nation has received a total of \$8,557,160.75 in CARES Act dollars for our Self-Governance programs under the Department of the Interior and \$51,364,059 in CARES Act dollars for our PL 102-477 programs. We have also received 17,757,154 in American Rescue Plan Act (ARPA) funds for our Self-Governance programs and \$165,631,972 in ARPA funds for our PL 102-477 programs.
