



Ambulatory Care Visits Month of June 2020-2024




<u>Dental Services</u> <u>Month of June 2021-2024</u>













Dental Services: Monthly





PUBLIC HEALTH PERFORMANCE MANAGEMENT

Performance Management

The implementation of the new performance management structure for Cherokee Nation Public Health (CNPH) commenced this month. This framework was developed to provide an organizational structure that facilitates continuous quality improvement, fosters partnerships, and strengthens tribal sovereignty by exercising the Cherokee Nation's inherent public health authority for collective well-being.

The new structure is comprised of five primary committees, each dedicated to key focus areas within our health department. These committees are focused on performance management, workforce development, partner engagement, communications, and ethics. They are pivotal components that report to the CNPH Executive Leadership Committee for evaluation and guidance.

Public Health Accreditation

The Public Health Accreditation Board (PHAB) delineates eight essential capabilities required in public health infrastructure. These foundational capabilities encompass cross-cutting skills and capacities vital for sustaining fundamental public health safeguards, programs, and activities that are instrumental in safeguarding community health, and well-being, and fostering equitable outcomes.

These fundamental capabilities encompass assessment and surveillance, community partnership development, equity, organizational competencies, policy development and support, accountability and performance management, emergency preparedness and response, and communications.

Earlier this year, our health department undertook an internal capacity assessment to pinpoint key focus areas for 2024-2025. The identified areas of emphasis included assessment, organizational competencies, and communications. Presently, our re-accreditation teams are actively developing project plans tailored to address these specific areas.

Quality Improvement

The quality improvement team is currently in the process of introducing a new document management software for our public health department. This particular software was chosen for its compatibility with Microsoft 365, SharePoint, and Teams. By leveraging this software, our department aims to enhance the efficiency of document review and approval processes while establishing a centralized repository for all CNPH internal documents. Furthermore, this software will promote uniformity in templates, increase accountability, improve audit functionalities, and facilitate convenient access for staff members.

Workforce Development

The workforce development team is responsible for strategically facilitating the growth of a proficient public health workforce. Presently, workforce initiatives are focused on addressing opportunities for improvement through aligning staff development and retention with the health department's mission, goals, and strategic priorities.

Currently, we are consolidating the training plans of each program into a comprehensive document for integration into the broader workforce development plan. Other ongoing initiatives include providing internal professional development opportunities, forming a workforce development committee, and exploring methods to enhance employee recognition.

Public Health Nursing

The public health nursing team is currently organizing community outings to offer services like blood pressure screenings, naloxone education and training, and STI prevention education. To schedule a training session or request a nurse's presence at a community event, please contact our Public Health Nursing (PHN) Supervisor at cherokee.org.

WORKING TOGETHER INITIATIVE

Phase 1: Cherokee Nation Public Health launched *Working Together*, an initiative to being partners together across Cherokee Nation to better understand and address the multiple social, cultural, economic, and environmental conditions that influence Cherokee well-being. A Working Together Team was then formed to review engagement outcomes, and to work towards the following goals:

- Create a shared vision for Cherokee Wellness
- Create a wellness framework reflective of the social and cultural determinants of health
- Identify indicators to determine how wellness will be measured

Phase 2 of the project which includes finalization of Cherokee Indicators of Wellness, expanded inclusion of staff from additional programs, and initial collaborative data collection and evaluation started in February. Additional leadership from Health Services, Career Services, Community Services, Indian Child Welfare, and Natural Resources have joined the team since the last report. Phase 2 work has been focused on the continued development of the framework as well as individual department meetings to identify potential measurable indicators. We currently are in the data collection and identification of measures process. Currently working on Spring 2024 meeting schedule.

PUBLIC HEALTH MONITORING, SURVEILLANCE, & EVALUATION

School Health Profiles

This is a system of surveys assessing school health policies and practices in the reservation, conducted every two years (even years) among middle and high school principals and leading health education teachers.

Profiles monitor the status of school health education requirements and context, physical education and physical activity, practices related to bullying and sexual harassment, school health policies related to tobacco-use prevention and nutrition, school-based health services, family engagement, and community involvement, as well as school health coordination.

The MSE team has started the school health profiles survey. So far, we have a 75% participation rate from up to 115 principals and 67 lead health educators taking the Profiles survey out of 143 eligible schools.

School Health

The MSE team has drafted assessment questionnaires for the PH School Health Program that measure Student Health and Health of the School Health Environments, to be administered at Cherokee Nation Sequoyah School (Grades 8th–12th), and Cherokee Nation Immersion School (Grades 3rd–7th). The focus areas are Physical Activity, Nutrition, and Tobacco use.

Youth Risk Behavior Surveillance (YRBS)

The YRBS survey tracks behaviors that can lead to poor health in students grades 9 through 12. This is conducted every two years (odd years). The MSE team has completed the current assessment process for this year. The school response rate was 94%, and the overall participation rate (school response rate and student response rate) was greater than 75%, exceeding the targeted participation rate. Results have been submitted to the CDC and should be available later this year. After surveying schools, they were provided with environmental sensors (vape detectors), which have been distributed.

Adverse Childhood Experiences and Protective Childhood Experiences (ACEs/PCEs)

Since the YRBS and Profiles surveys are consistent and have been sustained surveillance projects within MSE, we have incorporated ACEs/PCEs related questions into these surveillance systems. This is how we developed a sustainable way to collect ACEs/PCEs surveillance data.

<u>Data Modernization</u>

The MSE team is preparing for its second year of data modernization work plan activities. Objectives consist of enhancing public health data through the modernization of technology infrastructure, cultivating Cherokee Nation Public Health's capabilities to analyze with technology and supporting the use of results to improve population health, and forging

communication and collaboration with stakeholders to collect and share data that provide information on conditions of public health importance.

<u>Opioids</u>

The Johns Hopkins injection drug use study entitled "Our Stories Matter" successfully completed data collection in Sequoyah County during the Spring of 2023. The community response to the project staff's presence was overwhelmingly positive, with 600 surveys collected during the second phase of data collection alone.

The MSE Epi has completed the data analysis (quantitative and qualitative data analyses). The team is now in the process of publication pending a review by the CNIRB and CN Communications.

The MSE team has built an initial surveillance dashboard around opioids for professionals here at Cherokee Nation to use for planning resources and activities around opioid prevention or intervention. The team is enhancing the dashboard to match the public health opioid plan.

Getting to Y

An MSE epidemiologist works with students from four High Schools within the reservation who participated in the UP for Learning's Getting to "Y" program (GTY) during the 2022-2023 school year. Getting to "Y" is an opportunity for students to bring meaning to their YRBS data.

Through youth leadership, partnerships with adults, participatory action research, and peer and community engagement, participants experience personal growth by building their capacity for future civic engagement and effect sustainable change in youth behavior, community, and school culture.

6 schools are already signed up for this year; they all have a facilitator, core team, and data analysis team. Once 2023 YRBS data is finalized and validated, each school will hold its data analysis retreat and develop an action plan, which it will implement in this school year and next year.

Inter-Tribal Collaborations

Commerce Department – HOPE Program: A MSE data specialist is assisting in validating participants' eligibility based on program requirements.

Human Services – OneFire Program: A MSE epidemiologist and data specialist are working with OneFire in preparation for a data visualization and management system. We have been working with OneFire and CN IT on platforms that will meet the needs for the domestic violence staffs' case management data workflow.

Environmental Health – Community Water Survey: A MSE epidemiologist have worked with the Environmental Health team to launch a new survey for 2024. Our team is awaiting the results from that to help with analysis.

CNHS Infection Control Clinic – Syphilis Surveillance Project: A MSE epidemiologist is looking at risk factors and trends among Tribal health facilities users and building a report with the support of the Infectious Control Clinic. They are in the final analysis phase and should have a full report by the end of the year.

Wastewater Surveillance Process – As part of an ongoing collaboration for internal capacity, the MSE team is working with Environmental Health to develop wastewater surveillance activities and testing. They are in the process of designing a wastewater surveillance laboratory.

Language Department – The MSE team is working with the Language team to build a Cherokee speaker's survey (implemented in the Cherokee language) to understand their social determinants and health outcomes. It is expected that the survey will launch later this year.

Education – MSE met with the Education team to consult on data elements around program evaluation and addressed requests for assistance with tools or resources for the team to evaluate projects within the department.
