II. Program Highlights

a.) Motor Vehicle

- 1. Year to Date Motor Vehicle revenue for FY14 compared to FY13 as of February 28th 2014 & February 28th 2013, had an overall increase of 18.54%.
- 2. The month to month revenue comparison for February 2013 (FY13) compared to February 2014 (FY14) shows an increase of 26.29%.
- 3. The detail for all areas of revenue for motor vehicle is shown on the attached graphs.
- 4. In November there were 765 new tags issued December 588, January 743, February 763 and March 933 in the Extended Jurisdictional Boundary area.

b.) Revenue and Taxation Division

- 1. Year to Date Revenue and Taxation (Tobacco) for FY14 compared to FY13 as of February 28th 2014 & February 28th 2013, had an overall decrease of 3.20%.





Description of Budget exceptions: No budget exceptions to report. position was vacant and the staff reported to Vickie Hanvey. In January 2014, the Director position has been filled by Scott Otten. Two of three Self Governance Analyst positions are vacant.

II. Program Highlights

1. **NEGOTIATIONS:**

• IHS Contract Health Services (CHS) or Purchased and Referred Care (PRC):

We have submitted proposed language for expansion of CHS, or what is now termed Purchased and Referred Care. The Nation proposed to keep the of the funding agreement "as is", however IHS rejected that offer. The amendment for CHS (or PRC) will not move forward until the Contract Support Costs language is resolved. Our office is working with the Sonosky law firm to move forward with negotiations.

• Veterans Administration:

Health, Self-Governance, and the Attorney General's office are currently working with the Veterans Administration to complete a reimbursement agreement. The agreement, when finalized, would call for the VA to reimburse Cherokee Nation for health services provided to eligible Cherokee and American Indian veterans.

DOI: Fire Preparedness and Suppression

OSG and Risk Management met with BIA staff regarding issues pertaining to fire preparedness and suppression activities. A letter was sent to the Regional Office outlining the issues and requests from the Nation.

The Nation, BIA Regional Office and Oklahoma Department of Agriculture, Food and Forestry-Forestry Services, (ODAFF) are working on a MOU between the parties the purpose of which is to coordinate and formalize activities, policies, and procedures to maximize public safety and more efficiently manage wildland fire activities within the Cherokee Nation jurisdictional boundaries.

• DOI, OST Negotiations:

Negotiations to update the Office of Special Trustee (OST) Appraisal MOU and the Beneficiary Processes Program are expected to commence in the near term.

2. FY2015 President's Budget Request:

On March 4th, President Obama released his FY2015 budget request. It should be noted that Congress holds the ultimate responsibility for setting actual funding levels, but the President's request provides an important insight into each Administration's priorities. The FY15 budget request is of particular importance because of recent developments regarding contract support costs.

The overall IHS budget request for FY15 is \$4.634 billion. This represents a \$200 million requested increase over the FY14 enacted budget levels. The request includes \$617 million for CSC, a \$30 million increase over FY14 enacted budget levels.

The overall BIA budget request for FY15 is \$2.6 billion dollars. This request would be a \$33.6 million increase over enacted FY2014 budget levels. The President has requested \$251 million for BIA CSC. This is a \$4 million increase over FY2014 enacted budget levels.

3. Contract Disputes Act Litigation:

Vickie Hanvey and staff are continuing to assist the Cherokee Nation Office of the Attorney General with litigation against the United States Department of Health and Human Services for underpayment of contract support costs claims.

October 8, 2013: Cherokee Nation filed complaints for underpayment of contract support costs for FY 2011 and FY 2012 in the United States District Court for the District of Columbia. The case, along with several other Tribes' CSC claims, was assigned to District Judge Rudolph Contreras. Judge Contreras then assigned the cases to Magistrate Judge John Facciola for mediation.

October 30, 2013: An initial mediation conference occurred before Magistrate Facciola. Vickie and Clint attended the mediation conference where the Magistrate combined the Nation's CBCA claims (2006-2010) with the 2011, 2012 claims before the court. Therefore, all of our claims get considered together and we jump ahead of other tribes on the CBCA list.

November 14, 2013: The Nation and the Government sent discovery request as part of the mediation process per the court's order of November 4, 2013. As this mediation will cover all pending claims, the document discovery request seeks documents from FY 2005 through FY 2012. The Nation has 30 days to respond, however CN OSG has already previously provided to the Sonosky firm many, if not all, of the documents that the Government has requested.

February 10, 2014: Received a settlement offer from the government.

<u>February 27, 2014</u>: Received notice from D.C. Circuit Court that initial mediation session between IHS and Cherokee Nation is scheduled for August 4, 2014.

4. FY 2014/2015 Appropriations/Contract Support Costs:

In January, Congress passed, and President Obama signed into law, Appropriations for the remainder of FY2014. The FY 2014 Consolidated Appropriations Act bill contains an important new approach to funding contract support costs (CSC). This bill is different because it does not cap CSC spending in the aggregate or on a tribe-by-tribe basis. Congress gave the Bureau of Indian Affairs and Indian Health Service "lump sum" appropriations with limited instructions in an attached explanatory statement. Unlike prior appropriations, Congress did not set line-by-line funding levels for most tribal programs. Instead, Congress gave BIA and IHS a single "pot" of money with instructions to fully fund CSCs. The good news is that BIA and IHS received overall funding levels at, or above, their pre-sequester amounts. The bad news is that these increases will not make up the total amounts needed to fully fund CSC. The result is that BIA and IHS will likely be forced to take funding away from services in order to pay for the full funding of CSC.

In mid-February, BIA and IHS submitted their FY 2014 operating plans to Congress. The operating plans outlined how the two agencies planned to fully fund CSC for the remainder of the fiscal year. IHS opted to reduce funding levels to tribal management grants by \$1 million, the self-governance budget by \$1 million, and the Indian Health Professionals fund by \$5 million. Tribal management grants provide technical assistance to tribes looking to enter into/expand self-determination contracts and self-governance compacts. The self-governance budget covers many of IHS' administrative costs for oversight of self-governance compacts/funding agreements. The Indian Health Professionals fund is used to provide scholarship and student loan repayment opportunities for health professionals that enter into careers at IHS facilities. IHS officials have stated that they chose to reduce these accounts because they do not fund services that are used to directly administer health care services to tribal citizens.

5. BIA/IHS Contract Support Costs Consultation:

On March 11th, the BIA and IHS held a joint tribal consultation session regarding contract support costs. This session was the first of a series of congressionally directed consultations with Tribes regarding long term plans to fully fund CSC. The two agencies each have until May 17th to consult with Tribes and submit a long term CSC "work plan" to Congress. The work plan

must outline the BIA and IHS' long term vision to provide full funding for CSCs in accordance with the Indian Self-Determination and Education Assistance Act. Cherokee Nation Self-Governance actively participated at this consultation session and provided direct input to DOI Assistant Secretary Washburn, IHS Director Roubideaux, staff from the Office of Management and Budget, and senior members of President Obama's Domestic Policy Council.

6. Oklahoma SG Coalition:

February 20, the Oklahoma coalition of SG tribes met to discuss and collaborate on issues pertaining to budget and contract support costs.

7. BIA/IHS Contract Support Cost Workgroup:

The week of February 24, IHS and BIA workgroups met to formulate recommendations to the agencies regarding the development of "work plans" due to Congress May 17th. Vickie Hanvey participated during the week on behalf of EORO and TSGAC.

8. 2013 Department of Interior American Indian Population and Labor Force Report:

In late January, the Department of Interior released the 2013 American Indian Population and Labor Force Report. The labor force report has been important in the past because its data was used in various formulas to fund federal programs administered by tribal governments. The source of population and labor force data in the 2013 report is the 2010 census. Prior versions of the report relied on data submitted by individual tribes in response to surveys from the federal government.

In early March, Self-Governance staff convened a meeting with members of multiple Cherokee Nation departments to discuss the potential impact of the new Labor Force Report. Staff from community services, health, evaluation and compliance, career services, commerce, and the Secretary of State's office all participated in the meeting. DOI has scheduled a listening session on March 12, Self-Governance staff will participate and discuss concerns with the labor force report. Additionally, the Self-Governance Office is working with other departments within Cherokee Nation to develop a letter to the appropriate DOI officials outlining our concerns with the new report which could affect program funding formulas for several programs including NAHASDA and Roads.

9. Administration for Children and Families Tribal Advisory Committee:

Vickie Hanvey is the Administration for Children and Families Tribal Advisory Committee Region 6 representative. On March 4th and 5th, the quarterly meeting was held in Washington DC, due to inclimate weather she participated in the ACF TAC meeting via conference call.
