II. Program Highlights

a.) Motor Vehicle

- 1. Year to Date Motor Vehicle revenue for FY15 compared to FY14 as of November 30th 2014 & November 30th 2013, had an overall increase of 20.12%.
- 2. The month to month revenue comparison for November 2013 (FY14) compared to November 2014 (FY15) shows an increase of 4.06%.





Description of Budget exceptions: No budget exceptions to report. Two of three Self Governance Analyst positions are vacant.

II. Program Highlights

1. Contract Support Settlements- Thank you

Vickie Hanvey received correspondence from Port Gamble S'Klallam Tribe acknowledging her work on Contract Support Cost at the national level and sharing credit for the settlement they received. See correspondence on page 3.

2. FY 2015 Appropriations:

In mid-December, Congress passed H.R. 83, commonly referred to as the "Cromnibus," to provide funding for most of the federal government through the end of FY 2015. The FY15 BIA budget is approximately \$2.601 billion, an increase of \$70 million over enacted FY14 levels.

The FY15 IHS budget is approximately \$4.642 billion, a 4.5% increase as compared to FY14. Several important line items within the IHS budget received significant increases in the FY15 enacted budget. The FY15 IHS budget will fully fund CSC at roughly \$663 million, a \$75 million increase as compared to FY14. The FY15 Purchased and Referred Care (formally known as Contract Health Services) budget is \$914 million, a \$35 million increase.

3. Department of Interior PL 102-477 On-Site Review Report:

The Department of Interior is required to perform an on-site review of the Nation's PL 102-477 Program once every three years. In August, Yvonne LaRoque from the Bureau of Indian Affair's Division of Workforce Development visited the Nation to perform an on-site review. In early December, the Nation received Ms. LaRoque's written report detailing the results of her on-site review. The report stated that the Nation's 477 Programs "were well organized and the staff of both Career Services and Child Care showed a great deal of enthusiasm for their fellow co-workers, programs and the clients/members they serve."

4. Bureau of Indian Affairs Roads Inventory:

The Self-Governance Office, Roads Department, and Attorney General's Office are reviewing the status of the Nation's 2012 Indian Reservation Roads (IRR) Inventory update. The BIA did not include 2.0 miles of roads located on the Sequoyah High School campus to the Nation's IRR inventory as requested by the Nation in 2012. After several months of delay by the BIA, discussions regarding the SHS roads resumed in December. The BIA is currently reviewing the status of land ownership at SHS. Self-Governance, Roads, and AGs office staff will participate in a follow up call with the BIA in late January or early February to discuss the next steps regarding adding the SHS roads in question to the Nation's IRR inventory.

5. Inter-Tribal Council of the Five Civilized Tribes:

Office of Self Governance staff participated in the January 8th-9th meeting of the Inter-Tribal Council of the Five Civilized Tribes.

Arkansas Riverbed Authority:

Vickie Hanvey made a presentation of "litigation support" funding available balance through the Nation's compact. Funding for the ARA is facilitated through the Cherokee compact but is designated for the ARA and under the express authority of the ARA. Governor Anoatubby and Chief Batton expressed appreciation for the presentation and requested Ms. Hanvey's assistance in facilitating a new budget for the ARA.

Governance Committee:

Ms. Hanvey also facilitated the Governance Committee meeting Representatives of the Five Civilized Tribes were joined by staff from the Comanche Nation, which is beginning to explore the possibility of joining Self-Governance in the near future. The tribes discussed a wide array of topics, including the BIA CSC Class Action lawsuit, funding formulas in the BIA, Johnson O'Malley student counts, and the current status of the BIA and IHS CSC Workgroups.

6. Oklahoma Self-Governance Coalition Meeting:

On January 6th, Self-Governance staff attended the Oklahoma Self-Governance Coalition meeting in McAlester, Oklahoma. The Oklahoma Self-Governance Coalition is open to all tribes in Oklahoma that are currently participating in Self-Governance or are interested in learning more about the Self-Governance initiative. Tribes from across the state shared updates about contract support costs, Medicare like rates, uncompensated care waivers, budget equity in the BIA, and many other topics.

7. Annual PL 102-477 Report

The Self-Governance Office submitted the Nation's annual Public Law 102-477 Report to the Department of Interior on December 23, 2014. Self-Governance staff worked with the Child Care, Career Services, and Finance departments to compile the necessary data for the report. The report contains a narrative, financial, and statistical report that details the Nation's efforts to implement its PL 102-477 Plan. The 477 Program allows the Nation to better coordinate services designed to provide employment and job training services to its citizens.

8. Administration for Children & Families Tribal Advisory Committee:

On December 11th, Vickie Hanvey participated in a meeting of the Administration for Children and Families (ACF) Tribal Advisory committee that was held via conference call. The conference call focused on the development of updates to the ACF's tribal consultation policy.

9. IHS FY2017 Budget Formulation:

Clint Hastings participated in the December 8 budget formulation meeting in Oklahoma City along with Dr. Charles Grim. The OCAO shared an overview of the budget formulation process, Area profile summary and performance measures, OEH, Contract Health, Contract Support and many other topics. Area representatives were selected for the National meeting in Washington DC.
