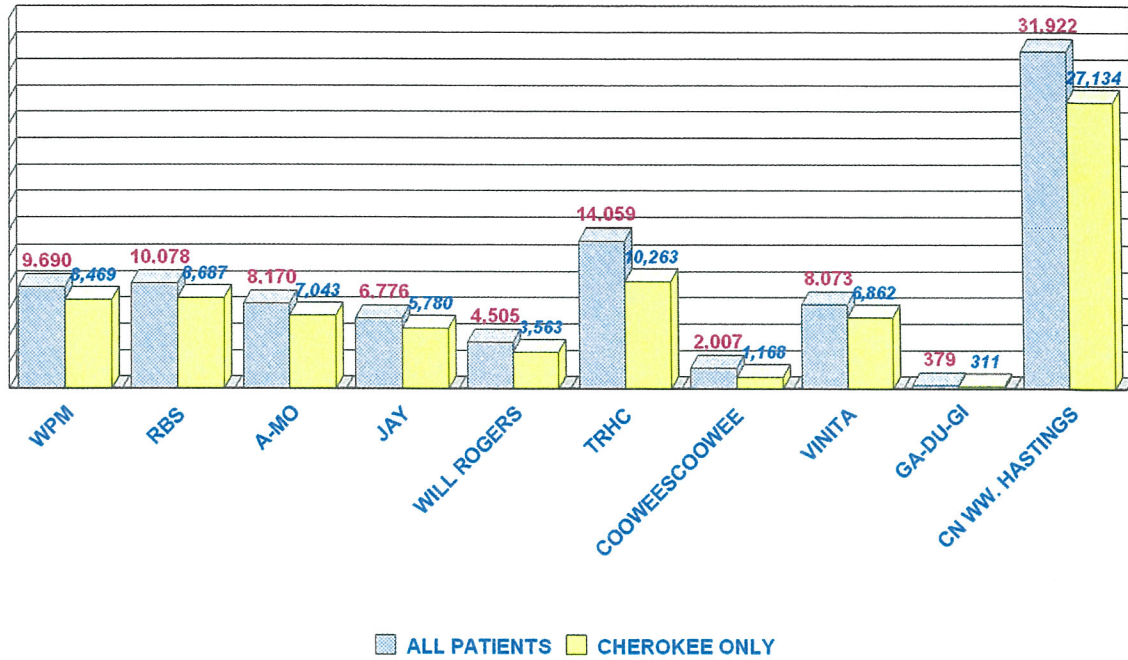

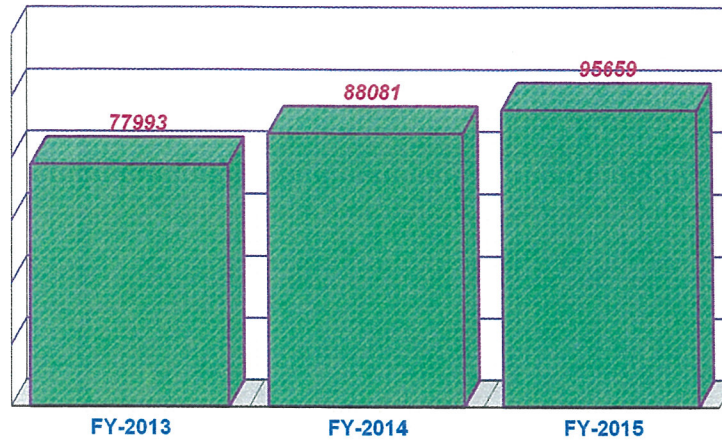

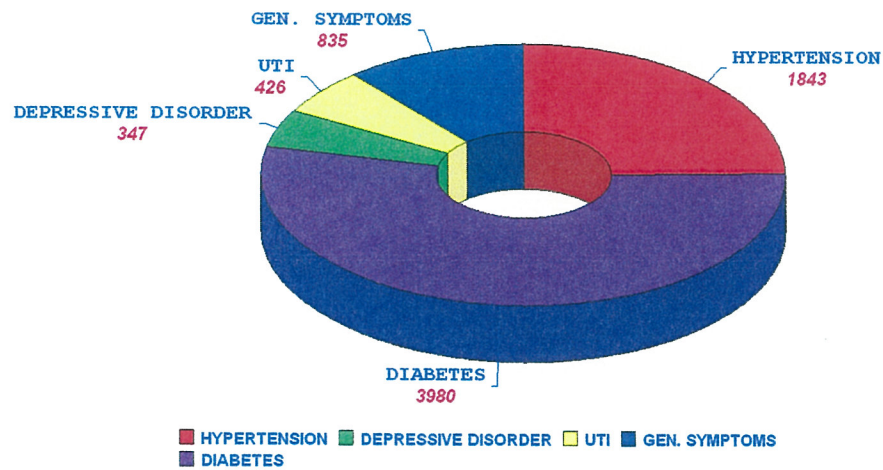
### AMBULATORY PATIENTS VISITS BY CLINIC, June 2015



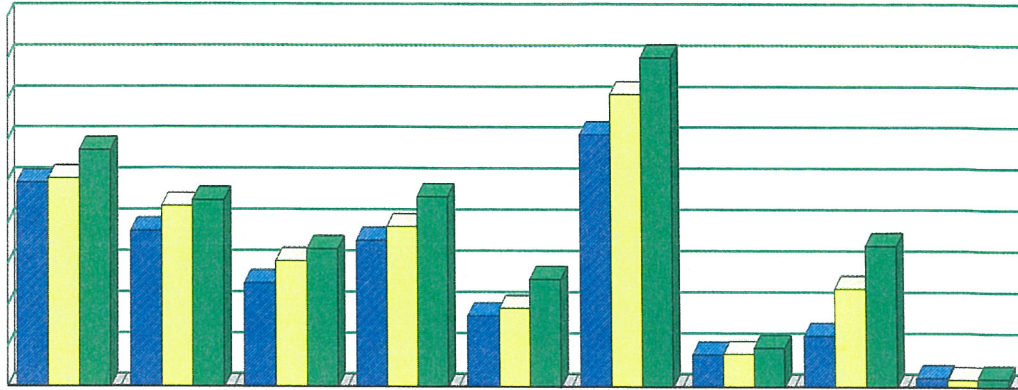
## TOTAL AMBULATORY PATIENTS VISITS BY CLINIC, JUNE 2015



## TOP FIVE PURPOSE OF AMBULATORY CARE VISITS, DURING JUNE 2015

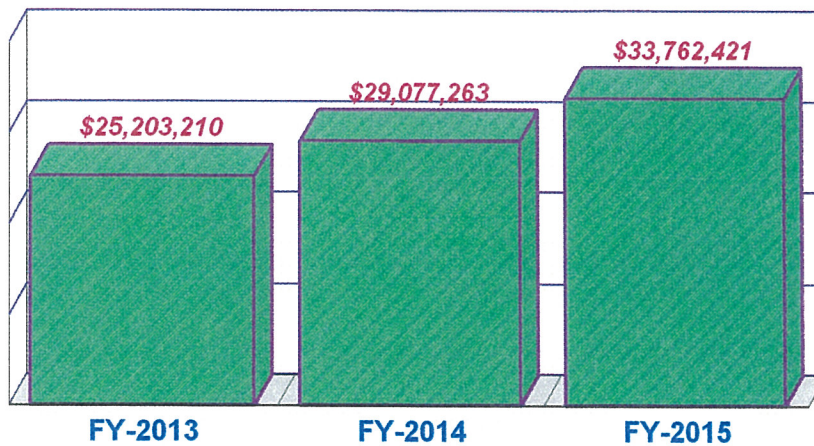


## Third Party Revenue By Clinic, JUNE 2015 (YEAR TO-DATE)



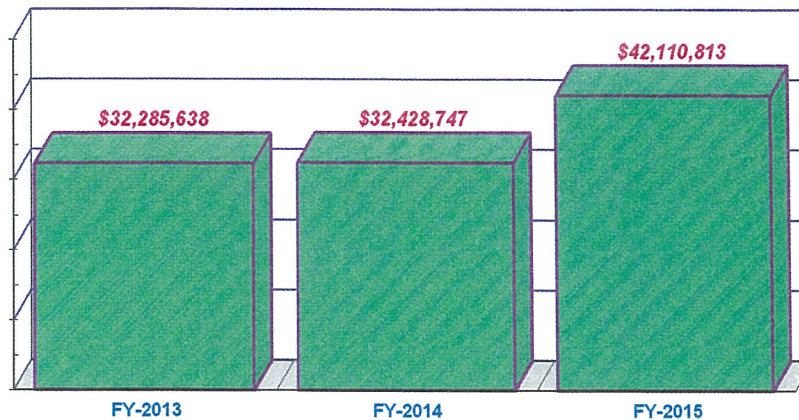

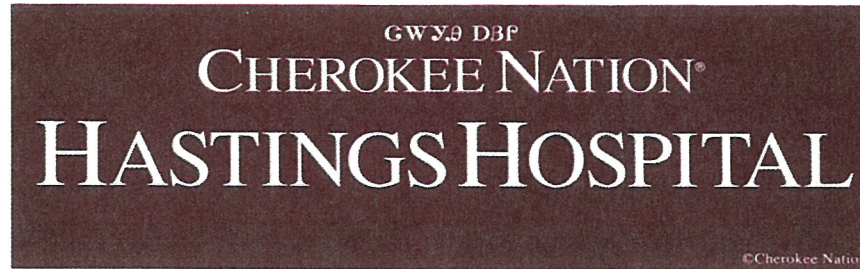

### **Announcements**

Operation Orange was conducted on Thursday, June 11, 2015, at Sequoyah High School's gymnasium with another excellent turnout of local high school students and was considered another great success by Dr. Kayse Shrum and her staff from the OSU College of Osteopathic Medicine. We had approximately 120 register for the event and 71 students attend.

### **Achievements**

Because multiple patients present to the Emergency Department (ED) and Urgent Care simultaneously, it is necessary for patients to be quickly and accurately triaged. All the Registered Nurses in the ED and Urgent Care attended Triage First training as part of our ongoing efforts to improve the care and patient experience in the ED and Urgent Care. Triage First teaches ED nurses how to triage based on the Emergency Severity Index (ESI), an objective, five-level acuity scale used in most EDs across the nation. Triage First has trained over 30,000 nurses nationally in hundreds of EDs. The goal of Triage First is to elevate ED triage skills, improve throughput, enhance patient and staff satisfaction, and thereby reduce Left Without Being Seen (LWOBS) and Length of Stay (LOS). The course consisted of a two-day interactive training in the classroom followed by completion of online training modules.

We have completed the replacement of our Medical Air Compressors for both Medical and Dental applications. The new system represents a significant investment to upgrade our single obsolete compressor and brings the hospital in compliance with new codes requiring separate systems for each service.

### **Volume**

The ED and Urgent Care treated 5,970 patients during June 2015 and experienced a Left Without Being Seen (LWOBS) rate of 3.64% in the ED and 3.93% in Urgent Care.

ED Arrival to Discharge time held at 159 minutes; ED Arrival to Transfer was 336 minutes; ED Arrival to Admission to Med-Surg was 423 minutes and ED Arrival to Admission to ICU was 336 minutes. The ED continues to perform well on its Core Measures with 100% performance again in June 2015 (this data is delayed due to data abstraction).

- Surgical Services performed 397 surgical procedures during June 2015.
- The Average Daily Patient Load (ADPL) for WWH during June 2015 was 20.27.
- Patient Transport transported 89 patients during June 2015, traveling 5,787 miles.

This can be a 6-12 month recall appointment after all treatment is complete or a new patient exam for someone who has never been to our facility before or has not been seen other than for emergency treatment in over a year.

- Diabetes Program-** 121 patients attended the Diabetes Self-Management Education classes in June. Program submitted to IHS the Final Report for FY 2014 (which ended on March 31, 2015, because we are on the 3<sup>rd</sup> funding cycle) for the Special Diabetes Program for Indians Community-Directed Grant Program. Meeting on June 3<sup>rd</sup> with Gina Fletcher and Ami Sams to develop a plan to be able to provide diabetic shoes through Contract Health, using Diabetes Program SDPI funds.

- **Diabetes Prevention Program (DPP)** – The program has served **675 participants. 261**,Active DPP participants for the month of **June**. Continued coaching visits and “Summer Slim Down Challenge” which began on May3,2015. Mailed 307 encouragement letters to participants. Continuation Grant App submitted. Sessions 13-16 were taught in Tahlequah to 8 participants. They lost a total of 65.4 pounds. Two participants met their goal weight. Sessions 13-16 were taught to 12 prediabetes patients at Salina Clinic. They lost a total of 91.8 pounds. Three participants met their goal weight.
- **Dietary Services** –Reports that they served **840 clients** during the month of June. **MNT Classes: 52 (This is the number of participants in the classes)** **Worksite Activities:** PN Classes, DSME Classes; DM Classes; Lipids Classes, Hypertension; Weight Mgmt. Classes; Pre DM; Cooking Classes; Kids Boot Camp; Blood Pressure Class; DPP Classes; Kidney Health; Employee Wellness. **Special Projects:**, DM MNT Weekly Audits, Log Teaching Kitchen Refrig/Freezer Temps-weekly, Notify Nurse Manager weekly of DM pts that need added to DM Registry, Reviewed policies in Policy Tech, Research nutrition info needed for patient appts, DM Registry- Add patients to registry, Gro Store/ Prep-DSME Classes, Employee Activity Committee Activities, DM Ancillary Clinic, ISU Dietetic Interns, OU Dietetic Interns, RD Share folder Review, Kid’s Camp Planning, Intern Evaluations, DM Registry- Add patients to registry, Learn to Grow Planning/Prep., PDSA, Chart Audits
- **Breast and Cervical cancer early detection Program** – The program served **305 Indian/Cherokee women** (Clinical Breast Exam, Mammograms, Ultrasound, Pap smear, HPV testing, Colposcopy with or without biopsy, and Colposcopy w/ ECC and ECC) at the cost of **\$35,447.75**. Educational events were held at the Nowata clinic, Sam Hider Health Center in Jay, Cookson Methodist Community Church, Cooweescoowee Health Center in Ochelata; the program also participated in a Sr. Citizens Health Fair and Presentation in Hulbert and in Miami, OK.
- **Behavioral Health Services**– Behavioral Health provided mental health and substance abuse services for **2185** patient visits, of those **1275** were **unduplicated patients**. Of the patients served at the Tahlequah and CIH sites, **1069** were Cherokees citizens
- **Jack Brown Center**– JBC held the monthly safety meeting. Staff members attended the Mental Health Awareness Day, Health Safety Meeting, CN Health meeting and the Health Environmental committee. The JBC served a total of **31** clients of those **16** were males and **15** were females. **24** patients are on waiting list.
- **Cancer Registry**– The program has been granted two years of funding by the National Cancer Institute. Presently the Cherokee Cancer Registry now has a total of **7,042 cases** in the SEER\*DMS system. **Top Cancer Sites:** Lung and Bronchus, Breast, Prostate, Kidney and Renal Pelvis.
- **CN Emergency Medical Service**–CN-EMS handled **487 calls**, of those **183** required emergency transport, **151** were transferred, **4,072 clients** have been served year to date. In addition program provided EMS training to **677** participants of those **506** were Native Americans.
- **Health Facilities Program, June Report**- Opened 119 work orders during the month of June, completed 122 work orders from June and previous month. 85% of the preventive maintenance items were completed in the issued month. Staff conducted a Life Safety inspection on Cascade and Reviewed double wide modular office for use by Surgery Tech. The program Director met with safety officer and clinic director at Cooweescoowee health center to develop their safety program, also performed safety inspection of Cooweescoowee Health Center

### **Public Health Accreditation**

Our Public Health Accreditation site visit will be September 29th and 30th.

In preparation for our site visit, we:

- Have reserved 3 conference rooms at WW Hastings;
- Met with Ginger Glory in QI;
- Are routinely walking though the hospital to familiarize ourselves with the daily operations;
- We are currently waiting on our documentation content review from PHAB. (We have been told we should have it early to mid-June.);

### **Sequoyah County PHEs Mary Owl and Lacey Wallace**

- Smoking cessation classes were offered at Redbird Smith Health Center and Sallisaw Library.
- Held one day youth camp at Redbird Smith Health Center with 27 children participating. Activities included: marbles, fire truck and ambulance education, stick ball, tobacco tour, nutrition and garden activity.
- Held a health nutrition class.
- Met with Vian Peace Center to help plan a 5K/Fun walk fundraiser to offset the cost of providing healthy meals for students to take home during weekends. Children targeted in this program is through the school system that identifies children who will not have a meal at home other than the backpack meals. Also discussed Farm to School project. Center wants to develop a community garden to provide healthy produce for the students as well as the community. Greenhouse was discussed along with raised beds, fruit trees, and Farmer's market.
- Worked with the Brushy Community Action Organization, which handed out adult and children coats, bath soap, shoes, and backpacks to needy families in Brushy community. Over 300 coats where handed out.

policy makers were encouraged to attend the event to gain valuable knowledge of the services and programs available in the area.
