Budget Highlights

- June 2015 CNB consolidated net income of \$8.3 million was unfavorable to a budgeted \$9.4 million and \$528,000 lower than prior year. Consolidated revenue was \$1.5 million above budget and exceeded the previous year by \$8.9 million.
- CNE EBITDA of \$15.0 million was consistent with budget. Higher gaming revenue was driven by the newly opened Roland facility
 that opened during May and higher than anticipated revenue at the West Siloam Springs and South Coffeyville properties. Total
 revenue for June 2015 was \$48.3 million and was \$1.5 million above a budget and \$3.4 million ahead of last year.
- Technology Portfolio EBITDA of \$995,000 was \$220,000 below budget. June revenue was consistent to budget. The unfavorable variance was due to decreases in revenue from projects within CNTS.
- CNI EBITDA loss was \$517,000 unfavorable to budget due to a shortfall in revenue. Total revenue of \$5.6 million was \$980,000 below budget.
- The CNB Parent Company EBITDA was \$78,000 favorable to budget, primarily due to higher than anticipated revenue from the
 partially owned subsidiaries.
- Construction Services EBITDA was \$184,000 above budget. Total revenue of \$4.6 million was \$1.4 million above budget. The
 favorable variance was driven by earlier start dates than projected on the Dover 206 project as well as the Central Commons and
 Parking project.
- Combined, EBITDA at all other entities were \$136,000 below budget.

Operating Highlights

- CNE EBITDA of \$15.0 million in June was consistent to budget.
- Total revenue of \$48.3 million was \$1.5 million above budget. Higher than anticipated total revenue was primarily the result of the newly opened Roland facility that opened during May as well as higher than anticipated revenue at the West Siloam Springs and South Coffeyville properties. Food and beverage revenue contributed \$400,000 to the positive variance, which was driven by higher sales in the Food Court and Buffet at the Hard Rock property, the Buffet at the Roland property and sales at the South Coffeyville casino.
- Total operating expense of \$33.3 million was \$1.5 million unfavorable to budget. The unfavorable variance primarily resulted from higher expenses associated with higher revenue as well as higher than anticipated employee costs.
- The South Coffeyville Casino opened February 16th, 2015. The 17,000 square foot facility offers 300 games. The South Coffeyville casino opened ahead of the budgeted opening date of April 1st.
- CNB has agreed to lease property adjacent to the Hard Rock Casino to Woodmont Outlets, which plans to invest \$80 million into premium outlet shops to be called, "The Cherokee Outlets." The Outlets, along with a new Entertainment area, called "The District," is expected to be completed in 2016.
- CNB also announced plans for the Cherokee Springs Plaza, which will include retail, restaurants, auto sales lots, office space, convention space, two hotels, and a casino adjacent to the Cherokee Springs golf course in Tahlequah.
- Groundbreaking for the Roland property took place on April 29th, 2014 for a new casino and hotel. The Roland casino opened on May 19th, 2015, with the hotel scheduled to open the first guarter of FY16.
- The Creek Casino in Tulsa is planning a \$335 million expansion including a 500 room hotel tower, new casino and restaurant, pool bar, theater and event center, with an expected completion date of 2016.

Operating Highlights

- EBITDA loss was \$786,000, which was \$517,000 unfavorable to budget. The negative variance was due to a decrease in revenue primarily from the Manufacturing segment, which lowered consolidated margins by 6 points. The negative variance in EBITDA to the prior year of \$128,000 was primarily due to lower margins associated with the revenue mix between the Manufacturing and Distribution segments, offset by lower operating expenses.
- Total revenue of \$5.6 million was \$980,000 below budget. The Distribution segment revenue was \$4.0 million, which was \$294,000 over budget. The Manufacturing segment revenue was \$1.5 million, which was \$1.3 million below budget primarily due to customer delays on the Sikorsky S300 contract.
- Total operating expenses were \$6.3 million, which was \$463,000 favorable to budget. Cost of goods sold were \$486,000 lower than budget due to the lower revenue. Employee cost was favorable to budget by \$87,000 due to several open positions. Other operating expense was \$110,000 unfavorable to budget primarily due to healthcare costs which was \$135,000 higher than budget.

Operating Highlights

- The IT Portfolio generated revenue of \$12.8 million which was consistent to budget and \$1.5 million ahead of prior year.
- June EBITDA margin of 7.8% was unfavorable to a budget of 9.5%. This period's decrease in profitability was due to decreases in CSG and CNTS on projects with the US Forrest Service and USACE projects. The US Forrest Service contract was completed in May with a delay in the follow-on effort. The anticipated follow-on award is expected July. For the USACE project, the customer scaled back the effort causing an impact to profit during the month of June.
- Revenue from CSG and CNT of \$3.8 million was favorable to budget by \$470,000. The favorable budget variance was due to increased activity on the BIA contract and the US Fish and Wildlife contract in CNT. Total operating expenses for CSG and CNT of \$3.4 million were unfavorable to budget by \$320,000. The budget variance was due to the US Forest Service Contract ending in May and additional staffing costs for the USDA Aphis project.
- CNGS, CNTS and CNMC revenue was \$8.7 million which was unfavorable to budget by \$351,000. The unfavorable variance was due to decreased revenue in CNTS projects with US Air Force and USACE. The US Air Force contract had decreased activity for the month resulting in reduced revenue. The scope of the USACE project was reduced also resulting in a decrease in June's revenue. CNGS, CNTS, and CNMC operating expenses of \$8.0 million were unfavorable to budget by \$6,000. The unfavorable variances in operating expenses compared to budget are attributable to the increase in bid and proposal costs invested for winning new contracts.
- Cherokee Nation Assurance (CNA) revenue of \$274,000 was unfavorable to budget by \$143,000. The unfavorable variance was due to decreased revenue from the US Coast Guard and CNE contracts. Additional work for the US Coast Guard contract is slow to develop. CNE revenue impact is timing differences to budget. Operating expenses from CNA of \$279,000 were favorable to budget by \$130,000. The favorable variance was attributable to the decreased cost in contracts with CNE.

Operating Highlights

- <u>CNSD</u> EBITDA loss was \$135,000 below budget. The unfavorable variance to budget was due to decreased activity on the higher margin SAMD contract, and increased activity on lower margin projects in CNRW and CNSD.
- Construction an EBITDA of \$383,000 compared to a budgeted EBITDA of \$199,000. The favorable EBITDA variance was driven by the increased revenue from the Dover 206, Central Commons, and Parking project.
- Healthcare Portfolio EBITDA of \$82,000 had an unfavorable variance of \$8,000 to the budgeted EBITDA of \$89,000.
- APSE net income was \$379,000 in June 2015 resulting in a favorable variance to budget of \$374,000 and to prior year of \$384,000.
- <u>CCRC</u> net income of \$267,000 in June compared to a budgeted net income of \$97,000. The increase in net income was attributed to higher revenue on the Ft. Bliss tank trails project.

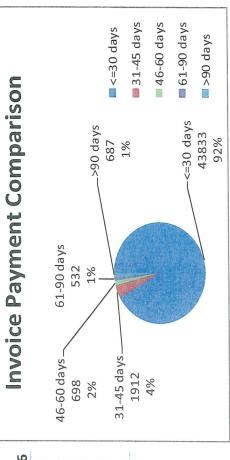

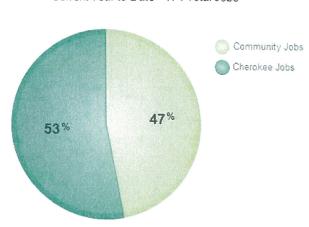
Jobs Created or Retained in Local Communities

Community Jobs Created or Retained Five Year Period 2010-2015 - 814 Total Jobs

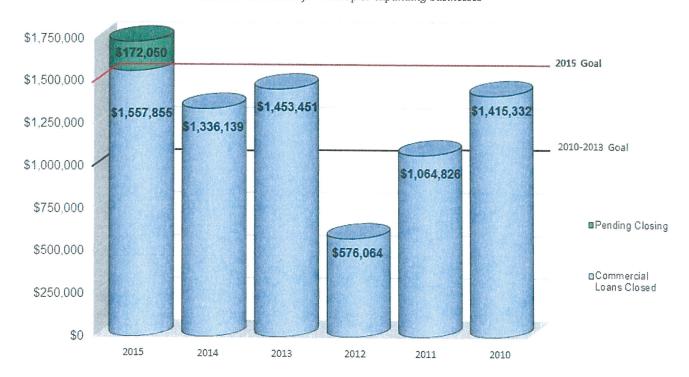

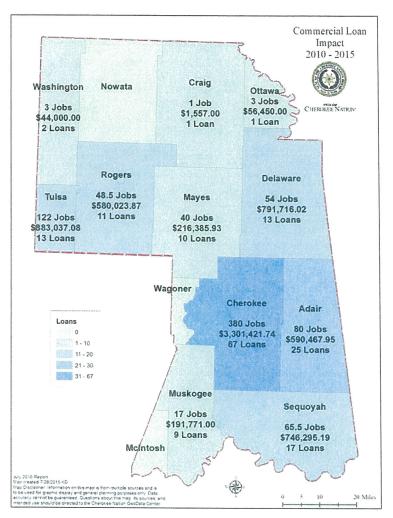


Economic Investment in Local Communities

All Traditional Cherokee Games are schedule for 10 a.m. and normally finish around 5 p.m., but there is no set time on finish. The following games are played: horseshoes, Cherokee marbles, corn stalk shoot, and blow guns. There are competitions for youth for corn stalk shoot, blow guns, Cherokee marbles and hatchet throwing. Hatchet Throwing is done mainly for fun and experience. Stickball is played if there is interest and the coordinators know in advance.

The 2015 **Arts on the Avenue** was held on June 12-13 at the Cherokee Capitol Square with a total attendance of **1,200** to the Art Center and Spider Gallery.

Year to date, **852 people have attended 178 artist taught classes** and the equipment has been used 985 times by 1,297 artists.

Year to date, **5,390 people** have taken advantage of the **Cherokee Arts Center** this includes **2,967 visitors to the Spider Gallery**.

The **Spider Gallery currently represents 94 artists.** The Gallery has participated in 9 events giving Cherokee artists

exposure to over 1,000. Total Spider Gallery Sales are \$38,218.90 for year to date.

Artists have earned \$78,732.14 through Cherokee Arts Center and Spider Gallery activities. Tourism related small business and artist loans total \$458,405 year to date.

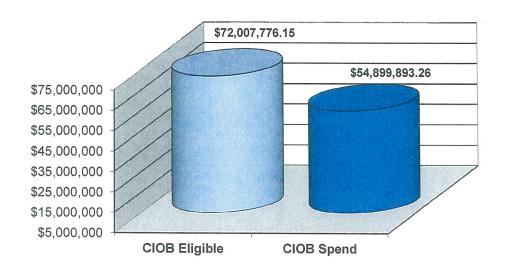

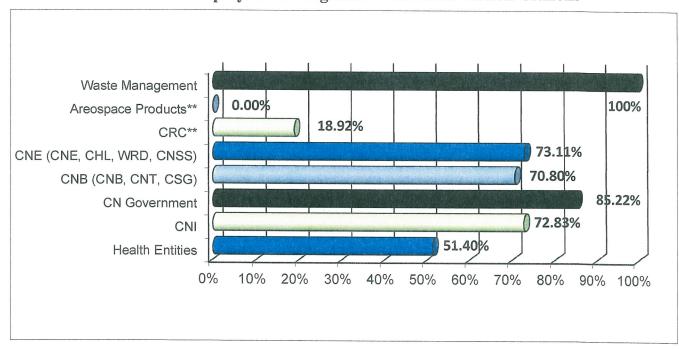
