- **Staffing:** Still recruiting physicians for Internal Medicine/Hospitalist, Family Practice, Surgery and OB/GYN. Recruiting Chiefs of Service for, Internal Medicine/Hospitalists, Family Practice, Surgery and Pediatrics.
- **Visits:** Outpatient visits for September up 10.4% over the same period the previous year.

### Announcements

**The transition to ICD-10**– was accomplished on September 30th at midnight with minimal disruption that can be attributed to the planning and preparation conducted by Health Information Management (HIM) and Health IT leadership and staff. Sherry Wallis was the Health IT Project Manager and has assured this transition went well with a pro-active communication plan. Our coding specialists will continue to focus on providing feedback to our providers to assure they continually improve their documentation and compliance with ICD-10 requirements. Our transition to Cerner ahead of the ICD-10 implementation has meant a far less disruptive change.

**Dr. Michael Arredondo, M.D.**, has joined the medical staff at Hastings and begun the process of integrating into the hospital. Dr. Arredondo will be participating in our morning report in an effort to develop our capacity to admit cardiology patients not requiring immediate interventional care. Dr. Arredondo is a **fellowship-trained cardiologist** specializing in electrophysiology.

**Diabetes Program-** 70 patients attended the Diabetes Self-Management Education classes in September. Held planning meetings for the FY 2016 Special Diabetes Program for Indians Community Directed Grant (SDPI CDG) competitive application, on September 2<sup>nd</sup> with Tara Ritter; on the 16<sup>th</sup> with Community Prevention Services supervisory staff; and on the 23<sup>rd</sup> with Dr. Elizabeth Harris at Hastings. Completed writing the grant application and submitted to Cherokee Nation Grants Management for review on September 30<sup>th</sup>. Conducted interview for Diabetes Program RN position at Nowata. Hired Kim Little, who started on September 28<sup>th</sup>.

**Dietary Services** –Reports that they served 567 clients during the month of September. **MNT Classes: 23 (This is the number of participants in the classes)** **Worksite Activities:** PN Classes, DSME Classes; DM Classes; Lipids Classes, Hypertension; Weight Mgmt. **Behavioral Health Services**—provided mental health and substance abuse services for 1901 patients. **Jack Brown Center**— JBC served a total of 26 clients of those 16 were males and 10 were females. 16 patients are on waiting list. Two clients placed 1<sup>st</sup> and 2<sup>nd</sup> place in the Cherokee Nation Holiday Blow Gun competition. 6 clients (4 males and 2 females) finished in the top four in wings race competitions. *JBC provided services to 100 clients for FY2015, exceeding contract requirements by 44 clients.*

**Cancer Registry**– The program has hired a new Cancer registrar Mr. Travis Wickliffe, who is a Cherokee citizen. All data reports are being submitted as are required by the funding agency.

**CN Emergency Medical Service**—CN-EMS handled 449 calls, of those 150 required emergency transport, 154 were transferred, 5,389 clients have been served year to date. In addition program provided EMS training to 784 participants of those 549 were Native Americans.

**Health Facilities Program-** Program opened 106 work orders, closing 113, carrying over 22; completed 99 preventative maintenance work orders, leaving 13 open. Program opened 126 move orders, closed 131, leaving 13 open. Staff conducted a Construction Risk Assessment for the contact plumbing work at Three Rivers Health Center, worked on ADA compliance for Healthy Nation, made handicap accessibility signs, met with safety officer at Cooweescoowee Health Center to assist with their safety program, conducted fire drill at Cooweescoowee Health Center, installed handicap accessibility signs at Bill Willis building 3, assisted Environmental Services with questions about Three Rivers Health Center, worked on revising the Safety Committee Responsibilities policy, acquired new mowers for Will Rogers, Red Bird Smith, and AMO Health centers, acquired new tractors for snow removal for Will Rogers, Redbird Smith, Cooweescoowee and Sam Hider Health Centers, repaired drain system at Jack Brown Center, requested 2014 equipment funds from IHS since CN acquired WW Hastings property, moved remaining Behavioral Health to new building vacating building at Health Living Campus. Health Services vehicle fleet has 156 vehicles.

### Public Health Accreditation

*Our Public Health Accreditation site visit occurred on September 29 – 30. Cherokee Nation is the only tribe in the nation which is being considered for this prestigious Accreditation. By all accounts and based on the final comments made by the site visitors Cherokee Nation health services were viewed very positively by the reviewers. We are now waiting to hear the report from the Accrediting organization.*

### Sequoyah County PHEs Mary Owl and Lacey Wallace

- Met with Turning Point Rep to discuss year 2 work plan to include working with Roland and Muldrow schools on adding “no vaping” to their current 24/7 tobacco free policy.
- RSHC Community Gardens Harvest Report:
  - RSHC Garden: 1.11 lbs. peppers; 5lbs jalapenos; Green tomato 3.2lbs, Peppers 2.4 lbs.
  - Marble City Food Pantry: 25lbs heirloom multi-color corn
  - Nutrition center: 20 lbs. green tomatoes for relish
  - Sequoyah Wellness Center: 20 lbs. green tomatoes
- PHE and PICH partner meeting with COTTA volunteer field specialist Tony Stayathome on getting volunteers to clear out property where greenhouse for aquaponic will be installed.
- Outside working day at Gore schools to install irrigation system.



### **Cherokee County – PHEs Greg Bilby and Hillary Mead**

- Attended a mini farmer's market at Greenwood Elementary School on September 8, 2015. There were 105 3<sup>rd</sup> graders who received \$12 in veggie bucks. A total of 6 vendors attended the market day.
- On September 10, 2015 went with a local farmer to present to two 3<sup>rd</sup> grade science classes which estimated about 40 students. The local farmer presented on the growth of a seed. The students were very interested in growing their own crops and wanted tips from the farmer.
- Heritage Elementary held their mini farmer's market on September 15, 2015. There were 87 third graders that received veggie bucks. Six local farmers were able to attend as well. Students received \$12 in Veggie Bucks. Several parents attended the market with their children.
- A market was held on September 22, 2015 at Grandview Public School. Third grade students were given \$12 in veggie vouchers to use at the market. The Food Service director wanted to have the whole school involved in the market, so she had two automated calls go out to parents encouraging students to participate in the market that day. The entire school, 730 students, visited the mini market that day. There were also several parents and staff purchasing fresh produce from the market. Vendors were selling out of all the produce they brought to the market. We received earned media from the event.
- 20 students from Keys learned about basic nutrition and how to build MyPlate. Students utilized food models to build breakfast, lunch, snack, and dinner plates. When students finished building their plates, they were asked to add up their total calories, fat grams, and other nutrients. When they finished the students combined their calories and discovered their meal was 1,200 calories.
- Presented to the Tahlequah Early Learning Academy parents on how to teach good eating habits to their children at a young age. The parents were given two handouts about nutrition.
- Coordinated the Veterans Holiday Run on September 5, 2015. There were 715 timed 5K runners and an estimated 200 fun runners.
- Health Fairs in Roland, Sallisaw and Miami. Set up information about Prostate Cancer and spoke about early screenings. Nearly 300 attended.
- Bird 5K Walk. About 500 participated in the fund raiser for the Leukemia Foundation.

### **Adair County – PHEs Charlie Stilwell and Tresa Eagle**

- We have worked with Dahlongah School so far we have garden projects in full swing. Fall Gardens are planted and producing produce for the kids to gather and use in their school cafeteria or give to the elders in their community. We recently purchased a small tiller, weasels, hoses, carts, gloves, garden equipment, compost container and soil to be ready for next year spring garden. The kids have collected their seeds and will use them to plant next year. They also have some new additions to their Worm Farm and have new babies growing they were very happy about that.
- Greasy school has their green house and raised beds ready to start working on their garden projects . We also purchased a small tiller, tools, gloves, and a cart for the kids to use and will start working on their soil and compost. We will teach the kids the proper garbage that makes good compost for their gardens.
- Dahlongah School and the Salem Community Garden expressed the desire to start canning their produce and teaching the students how this process works.
- Bell School turned in their new tobacco policy which included ESD and Vapor to their 24/7 Policy.
- We are working with ACE-HI and Brian Sitsler to get Schwan's Tobacco Free Business policy and survey once we get this survey and policy that will complete our first round of PICH.
- Dahlongah Garden Club is making a walking trail at their school and are bringing in different Native flowers, trees and plants that they are planting along their Garden Walking Trail. This is an awesome project that the kids are working very hard on and hopefully be completed before the winter.
- Visited with the superintendent of Rocky Mountain about possible Farm to school projects on PICH grant year 2. Rocky Mountain School has a greenhouse and a raised bed garden already but both have not been used in 2 years.

- Visited with Cave Springs School to check on the progress of getting its greenhouse operational however just the frame is up at this time.

#### **Delaware/Ottawa Counties – PHE Cindy Tudor and Trisha Nichols**

- Provided 24/7 tobacco free banners to Jay and Colcord schools.
- Met with Afton and Fairland city clerks about making their worksites 24/7 tobacco free and offered smoking cessation classes if needed. Also met with the schools to plan farmers market events.
