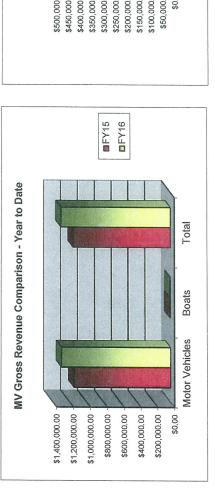

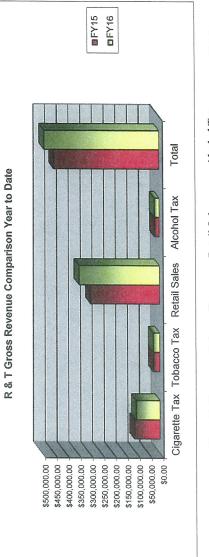

Description of Budget exceptions: No budget exceptions to report. Two of three Self Governance Analyst positions are vacant.

# II. Program Highlights

## 1. Indian Health Service Contract Support Cost Workgroup Meeting:

On November 4-5<sup>th</sup>, Clint Hastings attended and participated in a IHS Contract Support Cost (CSC) Workgroup meeting. In recent years, Congress has provided the BIA and IHS with appropriations sufficient to fully fund CSC, but the agencies are still in the process of updating their policies to define what constitutes full funding of CSC. The primary objective of the November 4-5<sup>th</sup> meeting was for federal and tribal CSC experts to explore ways that IHS could fairly and accurately estimate full CSC need on a tribe-by-tribe basis in a timely manner. In the time since the November meeting, a draft IHS CSC Policy has been developed and will be publicly shared at the December IHS CSC Workgroup meeting.

#### 2. Tribal Interior Budget Council:

Self-Governance staff attended the Tribal Interior Budget Council (TIBC) meeting on November 18-19<sup>th</sup>. TIBC is a body composed of tribal and federal representatives responsible for making annual budget recommendations for Indian Country programs within the Department of the Interior. BIA officials presented budget updates on ICWA, law enforcement, social services, and many other programs. Tribal TIBC representatives strongly encouraged BIA officials to dedicate a significant portion of any funding increases received in FYs 2016-17 to budget line items that provide the most flexibility to tribal governments. Tribal representatives stressed that they appreciate targeted budget initiatives supported by the President, but need funding that is flexible enough to allow tribal leadership to use federal funding in a manner that meets the needs of their local communities.

#### 3. Sequoyah High School Roads:

Self-Governance, Roads Department, and the Attorney General's office have recently met to reengage with the Bureau of Indian Affairs (BIA) regarding the status of the roads on the Sequoyah High School Campus. Sequoyah High School sits on land that is still owned by the BIA, but the BIA is not providing any support for roads maintenance on the SHS campus. Moving forward, the AG's office will be taking the lead on engaging with solicitors at the BIA regarding this matter.

# 4. Data Management Committee:

Clint Hastings participated in the quarterly meeting of the TIBC Data Management Committee (DMC) on November 17<sup>th</sup>. The DMC is charged with developing tribally driven methodologies for collecting relevant data that can be used to justify additional funding from Congress and other sources. Additionally, the DMC is working on methodologies to consolidate and streamline the hundreds of existing federal reports that many tribes must complete in order to continue receiving federal funding. The goal of this project is to reduce administrative burden on tribal governments in order to allow them to have additional time and resources to dedicate towards delivering services to their citizens.

# 5. Federal Highway Administration FY 2016 Referenced Funding Agreement:

The Self-Governance Office, in coordination with the Roads Department, has finalized Cherokee Nation's FY 2016 Referenced Funding Agreement (RFA) with the Department of Transportation Federal Highway Administration (FHWA). The RFA is the annual funding mechanism that sets forth the specific conditions, including programs, functions, services and activities to be performed by the Nation, funding to be provided by the FHWA, and the time and method of payment. FHWA signed and executed the RFA on November 13<sup>th</sup>.
