I. Budget Highlights

- 1. Received official award letter from IHS concerning FY16 Housing Support project. This project is to provide water and sewer facilities for New and Like New homes. Award of \$1,030,000 to serve an estimated 74 homes. This is an increase over the FY15 award of \$855,000 but still less than our FY12 award of \$1,140,000.
- 2. Still waiting on IHS project award notification for Regular project funds for existing homes. We anticipate the following projects will be funded but this list won't be official until we get an award letter:
 - a. FY16 Scattered Regular Project (All Counties) est. 100 homes
 - b. Ft. Gibson WTP expansion (Muskogee Co.) est 1507 homes
 - c. Kenwood North WL Extension (Delaware Co.) est 39 homes
 - d. Lowrey Phase II WL Extension (Cherokee Co.) est 21 homes
 - e. Osage WL Extension (Mayes Co.) est. 11 homes
 - f. Sequoyah Co # 5/Gore PWA Connection (Sequoyah Co.) est. 111 homes
 - g. Southern Delaware Co Regional WTP (Delaware Co.) est. 1141 homes
- 3. FY2016 Tribal Individual Funds are 48% expended. Only \$9,000 left in Budget Edit for contract services.
- 4. FY2016 Tribal Community Funds are 50% expended. We anticipate a large amount of remaining Tribal funds will be needed as matching funds for IHS projects.





a) The Cherokee Transit has received \$92,500 through the FTA Tribal Transit Program Discretionary Project. These funds along with a 10% tribal match will be used to purchase additional buses. Seven tribes including Cherokee Nation received funding through this program.

ADAIR COUNTY PROJECTS:

- 1. Chewey Road Designer: Red Plains Engineering. RP working on 90% completion. R/W will submit for appraisals as needed.
- 2. Dahlonegah South Designer: Holloway Updike & Bellen HUB. 90% checked plans were returned for revisions on 5/14/14. I met with Adair county commissioner Dale Dandridge February 8, about the acquisition and he told me he would be responsible for the acquisition of the fee property.
- 3. Bell North Designer: Red Plains Engineering. RP working on 90% plans. R/W received easements and exhibits 8/27/15 and is currently performing the first check of the documents.
- CNI Industrial Access Designer: D. Moore Contractor: Glover & Associates. Contract amount \$1,633,194.81. Construction underway working – light pole installation in progress --99% complete A final inspection was performed on the 23rd. awaiting final quantities
- 5. Dahlonegah West- Designer: Holloway Updike & Bellen. R/W is complete with research of ownership. 30% plans submitted on 8/28/15.
- 6. Lyon Switch Designer: J. Shehi and D. Moore. Plans have been submitted for revised alignment 45% check. East loop was removed from the project because of RW and environmental restraints at homes and historical structures.
- 7. Malloy Hollow—Designer: D. Moore. Plans are complete. Environmental review and negotiations with ODWC are still in progress.
- 8. North Salem (Bethel Road) Designer: Red Plains. RP are working on 90% Plans. R/W received the R/W documents 11/9/15 for first check.

COMMUNITY SERVICES COMMITTEE REPORT

- 9. Smith Hollow Designer: Red Plains Engineering. RP are working on 90% Plans. R/W received the appraisals 2/16/16. Notice of interest letters were mailed out 9/28/2015 to landowners. R/W is preparing to start acquisition.
- 10. Bell School South Designer: A. Harris Project is approximately 85% complete. Waiting on Guy Engineering to design a three sided bridge to replace a double box that will only carry a 2 year flood.
- 11. Rocky Mountain School Loop- Designer: D. Moore Project is 100% complete. CE approved. Bid advertisement scheduled for March 24, 2016 and Bid Opening scheduled for April 28, 2016.
- 12. Honey Hill Phase I Designer: HUB Engineering Design plans are complete. Utility letters were sent out for estimates for relocation. ADA Mike Ashworth informed John Compelube 1/27/16 that the condemnation cases have been dismissed. CN Roads department can now proceed with construction. Michael Lynn and John Compelube attended the Febrary 8, county commissioner meeting to confirm that CN Roads is ready to proceed with construction. Waiting on CE approval and utility relocations.
- 13. Bunch Road Designer: Nickle & Associates R/W has completed ownership research and sent it to Nickle & Associates 7/11/14. Decision was made to only do the portion from the BOP and stopping before the first railroad crossing. New task order was issued on 9-18-14 for the revised length of project. 30% plans were submitted on 2/19/16.
- 14. Oak Ridge Road and Oak Ridge Extension Designer: CGA Engineering. R/W has completed ownership research for Oak Ridge and mailed it 2/28/14. CGA will be doing the research for Oak Ridge Extension.. Completed 30% check and returned to CGA on 5/12/15. A community meeting was conducted on December 8, 2015 at 6:00 PM at the Bell school cafeteria.
- 15. Sally Bull Hollow Designer: Guy Engineering. R/W submitted the ownership research to Guy Engineering 12/17/13. 30% plancheck was completed on March 8, 2016 and PIH has been scheduled for March 30, 2016.
- 16. The following projects are pending design
 - Chance Road
 - Bidding Springs Road
 - Lyon South Road

CHEROKEE COUNTY PROJECTS:

1. Dreadfulwater Road – Designer: A. Harris. After the Preliminary Community Meeting held on September 18, 2014 the Roads department received one comment form from a concerned landowner. Plans are approximately 75 % complete.

- 2. Hulbert-Lost City Designer: A. Harris. Coordination with utility companies are underway. In house final review is complete and revisions are being made. R/W exhibits and easements has been started for this project.
- 3. Lost City Road Designer: Holloway Updike & Bellen. Right of way research is complete. Plans are 75% complete. Had meeting with utility companies to confirm easement placement on 1/12/16.
- 4. Northeast Fort Gibson- Designer: Holloway Updike & Bellen. Plans 98% complete. ABB survey was negative. R/W started acquisition 7/8/14, out of 129 parcels we have 1 parcel in Muskogee county left to acquire. Cherokee county acquisition is complete. Had utility relocation meeting on 1/12/16 to ask for relocation plans, estimates, and proposed beginning day of construction.
- 5. Tenkiller School –Designer: Red Plains. Contractor: Glover & Associates. Contract amount \$3,747,954.02. Construction: clearing and grubbing fencing 10% Complete.Contractor on site preparing for pipe installation.
- 6. Ross Street- Designer: D. Moore Survey is complete. Preliminary design is started. Attended the Infrastructure kick off meeting to allow CN departments and the City of Tahlequah to share with the Project Team for Hastings new hospital to share their knowledge of site issues. Still waiting to know where Hasting plans for driveway entrance. Waiting for Pavement design and hydrology from CGA.
- 7. Mud Valley Road Began preliminary design criteria. An exception will be submitted for narrower payment width. R/W has started ownership research for this project 11/18/15. Project is being flown by Quantum Spatial. Aerial targets are being set by survey crew.

CRAIG COUNTY PROJECTS:

- NS-4340 Road Designer: Guy Engineering (Contracted through the county).
 Held preliminary community meeting for the project 4/15/14 at the White Oak school cafeteria. R/W videoed the project and sent a copy of the video to Guy Engineering. 7/8/2015 R/W received Trust & Restricted documents from Guy Engineering for check. Currently preparing a list of corrections needed on the documents. Received Geotechnical Report on 8/4/14. Project design 85% complete. Field meeting for utility relocation will be May 5, 2015.
- 2. NS-4410 Road (7th Street/Turnpike Bridge) Designer: Guy Engineering (Contracted through the county). Cherokee Nation has signed the agreement between Cherokee Nation, Craig County, and ODOT.


- 2. A self sufficiency counselor will be permanently working out of the Stilwell Career Services office 2 to 3 days a week to provide assistance to families in Adair county.
- 3. Commerce Services will host a **home ownership fair** in early summer, more details will be forthcoming.
- 4. Commerce Services is once again partnering with the IRS to provide **free tax preparation** and filing services for low to moderate income families (under \$54,000); services are available until April 15th. As of March 15th, 1,067 tax returns had been prepared by Cherokee Nation's VITA program.
- 5. Since FY07, **667 families unable to obtain a non-predatory mortgage on their own** have completed self-sufficiency counseling and obtained a non-predatory mortgage.
- 6. YTD, Self Sufficiency staff members have worked with **9 families facing foreclosure**. Three families received a modification which includes one family receiving a foreclosure prevention loan and one additional family received a foreclosure prevention loan from the Small Business Assistance Center; two families are currently working with SBAC staff to save their home; one family was referred out for further assistance and unfortunately two families were unable to receive foreclosure prevention.
- 7. **640 consumer loans totaling \$780,895.13** have been made through the Small Business Assistance Center as of February 15th. Two of these were **Foreclosure Prevention loans totaling \$9,939.85**.
- 6. 74 families have used Mortgage Assistance to purchase a home this fiscal year.
