Real Estate Services is operated under a Self-Governance Compact with the Secretary of the Interior.

- 1. Sale or Purchase of Land. None during the month of June.
- 2. <u>Appraisals</u>. Two appraisals were requested; seven appraisals were approved by BIA.
- 3. Quiet Titles. Five Quiet Title requests were received, researched and returned.
- 4. <u>Inventory/Heirships</u>; <u>Report for Distributions</u>. 16 inventory/heirships were requested, researched and returned; none pending to date.

- 5. Report for Distributions, Summary Distributions. One Report for Distribution was requested, researched, prepared and submitted to BIA for finalization; one Summary Distribution was requested and submitted to Secretary of Interior.
- 6. <u>Last Will and Testaments.</u> Two LW&Ts were prepared and endorsed; one was approved in District Court; four new interviews were taken; and four drafts prepared.

- 10. <u>On-Site Inspections</u>, <u>Home Visits</u>, <u>Trespass issues</u>. Seven on-site inspections were requested and completed; two home visits were requested and completed; one trespass issue was addressed.
- 11. <u>Maps/platting/survey assistance</u>. 34 requests for maps/platting assistance was completed during the month.
- 12. <u>Jurisdictional calls</u>. 38 jurisdictional calls were completed during the month, with 15 after hours.

II Highlights:

- a) Staff have completed quarterly audits and maintenances at the following air shelters: Pryor, Newkirk, Tahlequah, Stilwell sites and the mobile station Air Station. These audits are required to show data from the sites are of the highest quality. During the week of June 27, Ross Fowler with Alion Science and Technology (EPA contractor) will be at the Roland air monitoring site for a Through-the-Probe (TTP) audit. Cherokee Nation historically performs well on these federal audits.
- b) Staff sampled Oologah Lake May 31, 2016 for water quality. Samples was tested for bacteria, ph, dissolved oxygen, salinity, turbidity, specific conductivity, total nitrogen, total phosphorus, alkalinity, sulfate, fluoride, chlorophyll-a, nitrite, nitrate, ortho phosphorus, temperature, nitrogen as ammonia, and heavy metals. The chlorophyll-a and permit metals samples were taken to Green Country Testing in Tulsa, OK for processing and analysis.

Staff also went to Copan Lake May 31, 2016 to view a fish kill that had happened on the lake a couple days prior. Staff spoke will Assistant Lake Manager Eric Bonnell about the kill and informed us Oklahoma Department of Wildlife were taking fish samples and water samples from the lake.

Staff attended a fish identification class June 1-2 that was put on by the Oklahoma Conservation Commission and Bureau of Indian Affairs. Staff learned traits that will help with identifying fish quicker and more accurately in the field. Staff will be using the new knowledge to identify fish for the upcoming fish tissue sampling.

Staff presented CNEP's fish tissue permit that will cover the entire Cherokee Nation 14 County area to the EPC commission on June 7th.

Staff responded to a fish kill on Sager Creek on June 13th alongside Oklahoma Department of Environmental Quality and Oklahoma Department of Wildlife Conservation. CNEP staff took water quality samples and readings from two separate locations along the Sager Creek. Samples were processed and sent to Green Country Testing on June 14th and should be receiving results in 2-3 days.

- c) The CNEP is coordinating with several other departments to formalize a fish/animal kill response team. This team would respond when there are fish or animal kills or suspected kills within the Cherokee Nation.
- d) Staff continued working with IS to complete tasks for the Exchange Network grant; This Exchange Network allows Cherokee environmental data to be directly loaded onto EPA databases where data obtained all over the United States is stored. Staff are working to

publish our air monitoring data on a publicly accessible website; our daily reports are currently routing to a test file transfer protocol site (FTP). The site should be available before the Inter-Tribal Environmental Council (ITEC) conference, where a presentation will be offered to the event.

e) Staff are working with the Cherokee Nation Attorney General's Staff on the bankruptcy of the Asarco Co. natural resources damage assessment and remediation (NRDAR) site. This is the potentially responsible party (PRP) at the site. Cherokee Nation will receive additional funding from the Department of Interior (DOI) to participate in the Tar Creek NRDAR Project too. The Trustee Council is still in negotiations with the PRP. The CNEP is working with the Cherokee Nation Attorney General's Office to determine if we will accept the settlement offer and to get the Tolling Agreement signed with the PRP.

f) Summer Camps:

Staff traveled to Kansas, Oklahoma to participate and teach environmental awareness at Camp Cherokee. Staff showed an educational video about spiders, and had a craft for the kids to make a spider out of recyclable egg cartons.

Staff traveled to Nowata, Oklahoma to participate and help with Camp Cherokee. Focus of this education outreach activity was to teach kids about pollinators.

Staff attended Camp Cherokee at Dwight Mission there were approximately 60 kids attending from the Sequoyah County area. Staff talked to the kids about recycling activities and then they made some crafts out of common everyday things that they can recycle from their homes.

g) Staff continues to work on the planning of the 21st Annual Inter Tribal Environmental Council (ITEC) Conference to be held at the Hard Rock Hotel Tulsa on July 19-21, 2016. Suggested topics for breakout sessions include: EPA Updates, Recycling/Solid Waste, Cultural Preservation, Water, Restoration, Environmental Issues, Environmental Health, Community Outreach, Superfund/Brownfields, Air and Tribal Profiles. Continued to work on the agenda, brochure and program design, and researched potential speakers.

h) Trust Application Activities:

- Staff contacted Cherokee Nation Real Estate Service Staff to get an update on the Bill Berry Property. Cherokee Nation Real Estate Service is still waiting for title and the abstract. Cherokee Nation Environmental Programs did not conduct any work on this project during this monthly timeframe.
- Staff conducted an inspection for the Clinic in the Woods Site to update the Phase I Report. Staff completed the update, conducted the interviews and assisted BIA during the final inspection.
