Real Estate Services is operated under a Self-Governance Compact with the Secretary of the Interior.

- 1. <u>Sale or Purchase of Land</u>. None during the month of July.
- 2. <u>Appraisals</u>. Two appraisals were requested; four appraisals were approved by BIA.

- 3. Quiet Titles. Two Quiet Title requests were received, researched and returned.
- 4. <u>Restriction Removal Applications</u>. Two restriction removal applications were submitted. Currently, one is completed and one pending.
- 5. <u>Report for Distributions, Summary Distributions</u>. One Report for Distribution was requested, researched, prepared and submitted to BIA for finalization; four Summary Distributions were requested and submitted to Secretary of Interior.

- 8. <u>Environmental Reviews.</u> Three environmental reviews (categorical exclusions) were requested and completed.
- 9. <u>Rights of Way, Rights of Entry, Service Line Agreements.</u> One Right of Way was submitted and pending; 10 Rights of Entry were requested and processed; one SLA was approved.
- 10. <u>On-Site Inspections, Home Visits, Trespass issues</u>. 17 on-site inspections were requested and completed; two trespass issues were addressed.
- 11. <u>Maps/platting/survey assistance</u>. 40 requests for maps/platting assistance was completed during the month.
- 12. <u>Jurisdictional calls</u>. 45 jurisdictional calls were completed during the month, with 21 after hours.
- 13. <u>Financial transactions</u>. \$168,134.51 was processed through the lockbox; and \$105,076.18 was received in the office for lease payments during the month.

- II Highlights:
- a) CNEP staff attended Camp Cherokee Thursday, June 16, 2016 at Kansas School in Kansas, OK. Activities included pollinator videos, making caterpillars, and pollinator work sheets. There were an estimated 60 students.
- b) Staff sampled Oologah Lake June 21, 2016 for water quality. Samples will be tested for bacteria, ph, dissolved oxygen, salinity, turbidity, specific conductivity, total nitrogen, total phosphorus, alkalinity, sulfate, fluoride, chlorophyll-a, nitrite, nitrate, ortho phosphorus, temperature, nitrogen as ammonia, and heavy metals. The chlorophyll-a and permit metals samples were taken to Green Country Testing in Tulsa, OK for processing and analysis.

Staff sampled Sallisaw Creek, Little Lee Creek, Caney Creek, Spring Creek, Spavinaw, Saline, Fourteen Mile and Flint Creek the month of June for water quality and stream flow. Testing will be done for phosphorus, ortho phosphorus, e.coli, enteroccus bacteria, ph, dissolved oxygen, salinity, fluoride, nitrogen, nitrite, nitrate, temperature, alkalinity, turbidity, sulfate, hardness, and nitrogen as ammonia.

Staff responded to a fish kill on Sager Creek June 13, 2016 but were unable to find any dead fish. Staff pulled samples and sent them to Green Country Testing for analysis since the water quality seemed to be poor with an influence of municipal waste effecting the stream.

c) Natural Resource Damage Assessment and Restoration (NRDAR)

Staff participated in the US DOI and Tribes NRDAR Conference call on July 5th. This conference call focused on US DOI Updates, NRDAR Acronym list, and planning for next year's Tribal NRDAR conference.

Tar Creek

Staff participated in the Tri-State Trustees Conference call on June 15th. This call focused on preparing for the Tribal portion of the Bankruptcy claim and developing a Scope of Work to collection information needed for this case.

National Zinc: No activities were conducted.

Tulsa County Smelter Complex

No work for the Tulsa County Smelter Complex was conducted during this monthly timeframe. Staff is awaiting review of the Pre-Assessment Screen from the Cherokee Nation Attorney General's Office Staff.

- d) CNEP staff attended the Self-Governance Advisory Committee in Washington, DC. The topic of self-governance at EPA was discussed and a subcommittee was formed.
- e) Staff presented the 21st Annual Inter Tribal Environmental Council Conference that was held at the Hard Rock Hotel & Casino in Catoosa, Ok July 19-21, 2016. Breakout sessions included: GAP Updates, Recycling/Solid Waste, Food Sustainability/Cultural Preservation, Water, Remediation/Restoration, Environmental Topics, Environmental Health, Environmental/Community Outreach, Superfund/Brownfields, Air and Tribal Profiles.

f) Trust Application Activities:

Staff continues to work on the Phase I Environmental Site Assessment (ESA) report for the Baker Property. A courthouse search for the Baker Property was conducted in Okemah, Oklahoma was able to trace the property back as far as possible. Staff mentored co-worker by helping with the Baker Property. Staff assisted with filling out the EDR Parcel Platform, looking at photographs, and the EDR Reports.

Staff completed the narrative details of the Subject Description of the property, buildings and structures for the Hwy 51 – 28.53 Acres Phase I ESA report. Staff continues to work on the list of the Recognized Environmental Condition and Environmental Concerns in the Environmental Report Summary and the Recommendations sections. A site visit was made to the property to measure the burned area and the concrete barrier on the property. Interviews with Cherokee Nation Water & Sanitation employees were also conducted during the site visit. The employees provided information about the contents of the 55-gallon barrels and the previous occupants and uses of the Water & Sanitation Building and the Facilities Warehouse. Information regarding the Above Ground Storage Tank (AST) and the interior insulation was provided by Elton Brown. The report is being conducted for Cherokee Nation Real Estate Services as part of the Trust Acquisition Package that will be submitted to regional Bureau of Indian Affairs (BIA).
