II. Program Highlights

a.) Motor Vehicle

- 1. Year to Date Motor Vehicle revenue for FY16 compared to FY15 as of June 30th 2016 & June 30th 2015, had an overall increase of 11.01%.







I. Budget Highlights - please refer to Monthly Financial Report

Description of Budget exceptions: No budget exceptions to report. All three of the Self Governance Analyst positions remain vacant.

II. Program Highlights

1. 2017 Office of Special Trustee (OST) Self Governance Program MOUs:

Completed the first drafts of MOUs between the Nation and DOI/OST for (1) Beneficiary Processes Program and (2) Appraisal program for FY 2017 and forwarded to OST for comments. These MOUs when completed will be incorporated by agreement to the Nation's Multi-Year Funding Agreement. The purpose of the MOU is to detail the coordination, implementation, duties and responsibilities of each party for the Nation's operation of these programs.

2 DOI and IHS Self Governance Advisory Committee Meetings:

The Interim Director, Government Resources, Cliff Powell, Director of Finance, and Tom Elkins, Director of the Nation's Environmental Program attended the DOI and IHS Advisory Committee Meetings. DOI - Of particular interest to the Nation is the effort to expand Self Governance to EPA. Mr. Elkins has been instrumental in this effort. Tribes would like to see a pilot demonstration project implemented at EPA before the end of this administration based on existing statutory authority. IHS – Much of the discussions revolved around the quality of care in the Great Plains Area and the solicitation by IHS for management of Great Plains Hospitals. They are open to any ideas or suggestions from Tribes on how to improve health care in Great Plains. Other topics of discussion included contract support costs and veterans reimbursement agreements.

3. Ramah Settlement:

The Government has now completed payment to the Class of the full settlement amount, \$940 million plus \$7,965,659.39 in post-judgment interest. We are waiting for the Government to provide information about the impact of the Treasury Offset Program on the transferred funds. Once Treasury provides that information, Class Counsel will ask for the Court's approval of the Claim Form dollar amounts for each Class Member. They hope by mid-to-late August to have received that approval. Once that approval is obtained, the Settlement Administrator will send out individualized Claim Forms to each Class Member. The Claim Forms will contain a specific dollar share for each Class Member, based on the percentage shares in the Final Settlement Agreement, as modified by Court order when additional Class Members were discovered.

4. 2015 Self Governance Activity Report:

Thanks to all of the Nations DOI program Directors and staff the 2015 Self Governance Annual Activity Report was submitted in order for the Secretary to meet the requirements of Section 405 of P.L. 93-638 as it relates to the submission of the annual report to Congress.
