Budget Highlights

- March 2017 CNB consolidated net income of \$17.2 million was \$3.5 million favorable to budget and \$1.6 million higher than prior year. Consolidated revenue of \$92.7 million was \$1.2 million unfavorable to budget but consistent with the previous year.
- CNE EBITDA of \$23.8 million was favorable to budget by \$2.5 million. The favorable variance was mainly due to higher than
 anticipated eGames revenue at most properties. Total revenue for March 2017 of \$62.7 million was \$2.9 million favorable to budget
 and increased \$5.1 million from the prior year.
- The Consulting Sector had a favorable EBITDA variance of \$650,000 due to higher than expected activity and profit margins on three projects.
- The Technology Sector had a favorable EBITDA variance of \$574,000 due higher profitability on three projects.
- CNB Parent had an unfavorable EBITDA variance of \$599,000 due to higher than anticipated operating expenses.
- EBITDA at the other entities was \$143,000 above budget.

March capital expenditures were \$34.1 million for all entities.

Operating Highlights

- CNE EBITDA of \$23.8 million in March was \$2.5 million favorable to budget.
- Total revenue of \$62.7 million was \$2.9 million favorable to a budget of \$59.7 million.
- Total operating expense of \$38.9 million was \$463,000 unfavorable to budget. The unfavorable variance was due to higher than
 anticipated gaming related expenses associated with higher gaming revenue as well as higher outside services and marketing
 related costs.
- The new 39,000 square foot casino in Grove, Oklahoma opened December 19th. The property features 400 electronic games, restaurant, full-service bar, live music venue, dance floor and complimentary non-alcoholic drinks.
- Businesses that opened at the Cherokee Springs Plaza in August include restaurants, retail and an auto sales lot. Additional
 businesses are anticipated to open in the future which will include retail, restaurants, office space, convention space, two hotels, and
 a casino adjacent to the Cherokee Springs golf course in Tahlequah.
- The Creek Casino in Tulsa opened a \$335 million expansion including a new casino and restaurant, all branded as Jimmy Buffett's Margaritaville, on August 25, 2016. The 483 room hotel tower opened December 30, 2016. The theater, Paradise Cove, opened January 6th. Ruth's Chris Steak House opened January 23rd. The pool bar and event center are expected to open in early 2017.

Operating Highlights

- Engineering & Manufacturing Sector EBITDA loss of \$586,000 was \$152,000 unfavorable to budget. The unfavorable variance to budget was primarily associated with lower overhead absorption. The gross profit margin of 14.8% was 4.1 percentage points higher than budget but 2.2 percentage points lower than prior year. The favorable margin compared to budget was associated with a change in product mix.
- <u>Logistics & Distribution</u> Sector EBITDA loss of \$33,000 was \$106,000 unfavorable to budget. The EBITDA variance when compared to budget was due to lower than anticipated revenue. Gross margins were higher than budget due to change in product mix.
- <u>Technology</u> Sector EBITDA was \$1.1 million compared to a budget of \$528,000, resulting in a favorable variance of \$574,000. The favorable EBITDA variance was primarily due to higher profitability on two CNT contracts and a CSG project.
- Consulting Sector EBITDA was \$1.6 million compared to a budget of \$912,000, resulting in a favorable variance of \$650,000. The 14.9% EBITDA margin exceeded budgeted and prior year margins of 9.2% and 10.0%, respectively. The favorable margin variances were due to higher than expected margins on three projects at CNMC, CN3S and CNTS.
- <u>Construction</u> Sector EBITDA of \$350,000 was \$122,000 favorable to a budget of \$229,000. The favorable EBITDA variance was primarily due to higher than expected profit margins from projects at CNCS and CNES.
- Health Sciences
 Sector EBITDA of \$517,000 was \$277,000 favorable compared to a budget of \$240,000. The favorable variance
 was due to two CNA projects.

- APSE net loss was \$53,000 resulting in an unfavorable variance to budget of \$399,000. Revenue was \$2.2 million unfavorable to budget.
- <u>CCRC</u> net income of \$114,000 was \$91,000 favorable to budget. EBITDA and gross profit margin were higher than budget primarily due to higher than anticipated profit on two projects.



As service providers, we sometimes wonder if what we do makes a difference. It's great when someone gets a job or completes a training program, but what happens then? Well, we've received a call from a former participant that reinforces all that we do. **Nancy Bryan** was placed at Keys School on **Work Experience** in 1985 then transferred to **On-the-Job Training**, completing the program in 1987. She has worked for Keys Public Schools for 32 years and is retiring this year. She wanted to thank us for helping her. Her retirement party is May 15th at 8am at Keys High School. Congratulations Nancy!

The **Sector Partnership National Dislocated Worker Grant** staff attended and participated in the New Way New Day Committee for Northeast Workforce Board, Muskogee Dream It. Do It., Mid America Delivers, and Men in the Making.

Staff attended and participated in Rapid Response with the Oklahoma Employment Security Commission for Tulsa Public Schools and for Free Ranger, as well as in the Tahlequah Workforce Partnership Meeting to develop a local Resource Guide.

Additionally, Brenda Fitzgerald, Director Vocational Rehabilitation and Daryl Legg, Director Tribal Economic Development/Reentry were asked to present information from the **Job-Driven National Emergency Grant** program at the Dislocated Worker Showcase for the Workforce Innovation and Opportunity Act National Convening Conference in Dallas in April.

The **Day Training Program** had 23 participants attain unsubsidized employment; eight with Cherokee Nation, 12 with CNB/CNI, and three with other employers.

The **Employment Development Program (TERO)** hosted a Safety Fair Friday, April 7th, 2017 from12:00pm - 3:00pm to show appreciation to the people who help keep us safe. Local volunteer fire departments, law enforcement, EMS, Emergency Management, Risk Management, and National Forestry Services were in attendance.

The **Employment Development Fire Program** has been very busy. Fire Fighters suppressed 18 fires in Cherokee Nation jurisdiction. They sent ten persons on a prescribed fire, and sent ten Heritage Resource Technicians out. Five firefighters assisted Osage Agency with multiple fires.

The **Tribal Economic Development Program** staff met with two different businesses looking to locate in Tulsa and in Owasso. Economic Development week is in May and the proclamation signing is May 10th at 10:30.




Dollars Invested in the Local Economy Through Small Business Lending

The Small Business Assistance Center partners with several groups in our region to provide entrepreneurial training opportunities, which leverages everyone's resources and targets a larger market. Year to date, entrepreneurial development and business workshops have been attended by 2,838 people, 100 percent of whom found the training useful to building the capacity of their businesses. Currently the majority of entrepreneur trainings conducted by SBAC staff is one-on-one. We have twenty entrepreneurs working on business plans and are conducting site visits with all current loan clients and evaluating individual training needs for business growth and best chance of success.

Increasing the business capacity of our Artists and tourism capacity of our communities


The Cherokee Arts Center provides teaching space and specialized equipment for artists to increase their revenues. Year to date, **672 people have attended 101 artist taught classes** and the equipment has been used 589 times by 391 artists. One artist space is used exclusively by the National Treasures to both work and to teach class. Year to date artists have taken advantage of the **Cherokee Arts Center 2,723** times.

The Spider Gallery currently **represents 120 Cherokee Nation artists and year to date has received 1,635 visitors**. Year to date sales total \$20,562.68 in the Gallery and **overall artists have earned \$46,095.64** through Cherokee Arts Center and Spider Gallery activities. **Online Gallery sales are in testing mode and should be fully operation in May or June.**




