#### II. Program Highlights

#### a. Contract Support Cost

The Senate's version of the FY 2019 appropriation for the Interior Department and Related Agencies, including IHS, intends to continue with an open-ended approach for fully funding contract support cost at whatever level is required. The estimated amount for all BIA contractors and self-governance Tribes is \$247,000,000 a 2% increase over the 2018 level. The estimated amount for IHS is \$822,227,000 a 14.5% increase over the 2018 level. Fortunately, the use of an "indefinite" appropriation means that if either of these estimates proves to be low, appropriations will nonetheless be available to pay all tribal CSC requirements in full.

#### b. Data gathering of unfunded obligations for Tribes

The Self Governance Advisory Committee through a letter dated June 22, 2018, to James Cason, Associate Deputy Secretary, Interior, expressed their disappointment with his response at the TIBC meeting in March regarding the elimination of unfunded obligations (UO) data collection efforts intended to support the annual BIA budget request. We have asked that he reinstate the UO data collection practices, and provide BIA staff with affirmative support and guidance necessary to accomplish their task. Without the BIA acting as the central facilitator in this process, it is impossible to create a complete picture of the unfunded federal obligations in Indian Country.

#### c. Farm Bill

FYI - On June 6, 2018, the Senate Agriculture Committee released its bipartisan version of the 2018 Farm Bill. Their version did not include the House versions controversial revamp of the Supplemental Nutrition Assistance Program (SNAP) that applied stricter work requirements to receive SNAP benefits. Other positive provisions for Tribes include: Adjusting the match requirements and funding limitations for the Food Distribution Program on Indian Reservations (FDPIR) so that economically disadvantaged tribes may reach more households in need of assistance; authorizing a new \$5 million demonstration project to allow some tribes to purchase some FDPIR food under self-determination contracts; and creating a Tribal Advisory Committee at the USDA.

#### d. Transportation Self-Governance Program Negotiated Rulemaking Committee

On June 19, 2018 the Tribal Representatives on the Department of Transportation Tribal Transportation Self-Governance Program (DOT-TTSGP) Negotiated Rulemaking Committee

notified the Secretary of Transportation of their decision to suspend participation in the rulemaking. The letter states in part, "We have made this very difficult decision because the Department, through it behavior over the past months, has failed to exhibit either the intent or the actions to show it is working in good faith towards a consensus draft of the rule to extend the Tribal Transportation Self-Governance Program to the Departments as required by the FAST Act, the Negotiated Rulemaking Act, and the Committee's own protocols". The Tribal Co-Chairs have requested a meeting with the Secretary on this matter.

#### e. Purchased and Referred Care Consultation

OSG General Counsel Bryan Shade attended a consultation with the IHS on June 14th in Phoenix, AZ regarding changes to the IHS Purchased and Referred Care policy. Of particular concern to the Cherokee Nation was IHS's omission of language relating to "former reservation areas" in the determination of eligible PRC areas. These concerns have been communicated with CN Government Relations for development of formal written comments which are due July 6.


