Education Committee Career Services June Monthly Report Diane Kelley, Executive Director

Alternative Education had nine students pass all components of the HSE (GED®, HiSET®) Test during the month of May. Our total graduate count is 45 (39 of which are Cherokee Nation citizens and six are members of a different federally recognized tribe.)

A June-July HSE Class schedule is now available. It will be in effect from June 1-July 31. A new fall schedule will be available in late July, but will not take effect until August 1, 2019.

Anna Christie has retired from her position as Adult Ed Teacher. Linda Pruitt's last day is May 31st, 2019.

The Career Skills Education Class had 84 individuals complete training.

Disability Employment Initiative (DEI) Program Manager, Marsha White and Disability Resource Navigator, Chrystal Lofton, are enrolled in and attending online classes to earn Certified Work Incentive Practitioner Certifications. This is a requirement for the Social Security *Ticket to Work* Program. Upon completion, both will be certified to be benefit planners for Cherokee Nation's **Disability Employment Initiative** and **Vocational Rehabilitation** Programs. Marsha White and Chrystal Lofton are also attending the required webinars for the *American Dream Employment Network* (ADEN). The webinars are required through ADEN, who is the contractor the DEI is using for the Employment Network, *Ticket to Work* Program.



DEI staff attended the Department of Rehabilitation Services Lunch and Learn series, Blindness Awareness and Mental Health in the Workplace trainings. DEI Staff also attended the Elevate Youth Conference, where youth ages 16-24 are exposed to potential Career Pathways. Marsha White attended the New Day New Way Meeting, a Northeastern Oklahoma Partners meeting, to gain knowledge of resources and upcoming events. She also attended the Mid-year Consortium of Administrators for Native American Rehabilitation Conference: *It's Not About*

Disabilities, It's About Possibilities. The conference explores creative ways to

empower Tribal Members and advance the beauty and culture of Native people. Lyndon Smith, Disability Resource Navigator, continues to attend the Northeastern Oklahoma Regional Alliance Leadership Program.

DEI staff will be collaborating with Oklahoma Workforce staff and employers in Northeastern Oklahoma to plan and hold a Reverse Job Fair for potential employees. We will also partner with Cherokee Nation's Tribal Employment Program for a job fair with Key Maintenance.



The **Disability Employment Initiative** program partnered with other Career Services programs,



Oklahoma Workforce, and Pelco Structural on a welding apprenticeship program. Eligible participants in the welding program met with different funding sources, including the Disability Employment Initiative program, to determine potential help in paying for tuition and required supplies. This collaboration shows overlapping services of programs to work together in providing services to clients.

The National Health Emergency – Dislocated Worker Grant – Opioid (Helping Others Perform Effectively HOPE), completed our first National Prevention Week (May 13-17). We shared daily prevention tips via email and concluded the week with a booth setup. Handouts and snacks (with prevention tips attached) were given to the public.

Ashawna Miles, **HOPE** Program Manager attended SMART training (Dallas, TX May 28-31), which focused on a variety of Federal Guidelines and regulation topics.

Career Services Management Team met with Tahlequah Police Chief Nate King; he and his staff will be conducting a Homeless Outreach Program beginning the Tuesday after Memorial Day, May 28, 2019. Mr. King had a meeting with all management team to explore the programs and services that we offer within our department for potential resources to this target population.



The **Trade and Economic Transition (TET)** program partnered with other Career Services programs, Oklahoma Workforce, and Pelco Structural on a welding apprenticeship program. Eligible participants in the welding program met with different funding sources, including the Trade and Economic Transition program, to determine potential help in paying for tuition and required supplies. This collaboration shows overlapping services of programs to work together in providing services to

clients.

The Pelco Apprenticeship Class has nine total participants. Six of the nine are Cherokee Citizens and we are currently helping these six with welding tool kits, vocational training at Northeast Tech, and on-the-job-training.

Accomplishments:

- 1) Six supervisors attended a 3.5 day Infant Massage certification training. To complete their certification they must successfully take an exam and provide a five week training to five sets of parents. The training was provided by ODMHSAS Training Institute.
- 2) The CNECU has been invited to participate in the second phase of the FACES research project (Family and Child Experiences Survey). We are working with the IRB and the Policy Council for approval.
- 3) The results of the second part of the Federal review that took place in September, 2018 have been received. The CLASS review, (Classroom Assessment Scoring System), involves observation and scoring of the classroom interaction, organization and the emotional support from Teacher to child. A certified reviewer conducts two 20-minute observations and scores the classroom operation. The results are basically a pass or fail. Pleased to report the ECU passed.
- 4) The Hastings Pediatric clinic is once again blocking time for Early/Head Start children's to complete all their health screenings—-physicals, dental, hearing and vision.

Upcoming initiatives:

- 1) The Policy Council will hold their regular monthly meeting on Thursday, June 20, 2019. Agenda items include approval of participation in the FACES project and One Time Health and Safety Application.
- 2) The Education Advisory Board is scheduled to meet June 13, 2019, to discuss the curriculum and all other related education areas.
- 3) Construction of the Children's Village storm safe shelter will begin this month as well as the water and sewer project. We anticipate a major effect on the playground, sidewalk and covering and fencing. However, it will all be repaired and placed back in the original condition.
