# Education Committee Career Services September Monthly Report Diane Kelley, Executive Director

Alternative Education had 11 student pass all components of the HSE (GED®, HiSET®) Test during the month of August. Our total graduate count is 72 (64 of which are Cherokee Nation citizens. Eight are members of a different federally recognized tribe.)

Preparations are being made for the 2019 HSE Graduation to be held on Thursday, September 19, 2019 at the Chota Center at the Cherokee Casino in Tahlequah. We are expecting approximately 325 attendees.

Career Skills Education Classes had 54 individuals complete.

**Disability Employment Initiative (DEI)** Staff attended the Externship Day at Adams Park Post-Acute Recovery Center in Bartlesville, OK to learn about career pathways in healthcare.

ADA compliance changes will be made to the Claremore Career Services office by October 31. The Career Services Building Trades Program will be making those repairs. Assistive Technology will be installed in all computer labs this month, with the Tulsa Career Services lab being first on September 20<sup>th</sup>.

#### **Disability Employment Initiative Participant Success:**



Ryan Reed, a 25-year-old Cherokee citizen, is employed as a database management analyst with Cherokee Nation Career Services. Although impressive, Reed's successful career path didn't come easy. "I was born and raised in Tahlequah, OK, and had numerous medical issues throughout my childhood," said Reed. All of those issues caused me to miss so much school I took the option of attending alternative school." Reed didn't finish high school but eventually earned his GED. He took entry level jobs with small companies then got a job at Cherokee Casino working with environmental services and players club for

approximately three years. Reed eventually visited

Cherokee Nation Career Services and became a participant with the Disability Employment Initiative, a grant awarded to career services through the Department of Labor. Reed had always wanted to work in the IT field and his original plans were to attend technical school. Career services' counselors worked with the IT department at Cherokee Nation to create a position through a work experience program in the networking group. "This group travels throughout all of



the satellite offices in the Cherokee Nation, said Reed." "It was very eye-opening to see how expansive the Cherokee Nation is and how many departments and programs reach out to assist Tribal citizens. There are some extremely talented people in our IT department." Reed was very excited to have found a niche in the IT field, especially in his hometown, and with the Cherokee Nation. "I was very happy with where my career was heading but things kept getting better, said Reed." "Career services approached me about working in their department with the prospect of eventually hiring me full time when there was an opportunity." Reed has had the opportunity to attend various workshops around the state and has gotten to work closely with other tribes on some of their projects. "I really appreciate everything career services has done for me, said Reed." "It's been quite a journey. I can't think of any way I could have done any of this on my own."

The Native American Career and Technical Education Program (NACTEP) Business Technology class assisted with the following during the month of August: Volunteer the Cherokee National Holiday with different events such as Parade, State of the Nation, Children Events, Softball, and Pow-Wow. Everyone did a wonderful job.

Career Services has just received word that our request to include NACTEP in the PL 102-477 Plan has been approved.

#### **Vocational Programs Participant Success:**



Kayla Fourkiller was working at Wilma P. Mankiller Health Center as a Medical Records Clerk. Ms. Fourkiller came in seeking help with the cost of attending Northeast Area Vo-Tech in Kansas, OK, for the LPN Program.

Kayla got into LPN school 2017. During that year, her family was doing great. Her husband was working and their daughter was enrolled at Zion Elementary. She was driving from Stilwell to Kansas daily to attend class.

The year of 2018, wasn't as pleasant for Ms. Fourkiller. Her husband left the family, and she was diagnosed with cancer, which resulted in her having a mental breakdown. Since she wasn't able to work or go to school, she was placed on hold for three months. She

had to have one surgery, in which everything went great. She was eventually released to go back to work and school. There was a time when she really didn't know about finishing the LPN Program. She finally came to the decision to finish knowing that she had to support herself and her daughter.

During her clinicals, Kayla drove to Grove, Jay, Muskogee, Broken Arrow, Tahlequah, and Siloam Springs, AR.

Kayla has been employed with Wilma P. Mankiller Clinic for eighteen years. When she completed the LPN Program, she transferred to a LPN position in the Drop-In Clinic and received an increase in pay. She is currently making \$31,240 a year, working 40 hours per week.

She is now doing well and her health is great. She also plans to begin the RN Program at Connors State College next year.

**Anna Belle Mitchell Memorial Scholarship** — Applicant must be an undergraduate, graduate student or community member who is currently pursuing pottery. Three pictures of artwork must be submitted with application. This is a one-year scholarship reserved for Cherokee Nation citizens.

**At Large Tribal Council Award** — Applicant must be a graduating high school senior with a <u>minimum 3.0 GPA</u>. Must reside outside of the Chekee Nation jurisdictional area and be enrolled full time in a four-year, postsecondary institution. This is a one-year scholarship reserved for Cherokee Nation citizens.

**Audie Baker Memorial Scholarship** — Applicant must be an undergraduate or graduate student with a <u>minimum 3.0 GPA</u>, majoring in special education at Northeastern State University. This is a one-year scholarship awarded in the fall semester, reserved for Cherokee Nation citizens.

**Bill Rabbit Legacy Art Scholarship** — Applicant must be enrolled in an accredited four-year, postsecondary institution pursuing a degree in fine arts or art education with a <u>minimum 3.0 GPA</u>. Accepted focuses include drawing, painting, sculpture, pottery, traditional beadwork and textiles. Must submit three pictures of artwork for review. This is a renewable scholarship reserved for Cherokee Nation and United Keetoowah Band citizens residing within the Cherokee Nation jurisdictional area.

**Brent & Janees Taylor, RSU Business Scholarship** — Applicant must be an undergraduate student majoring in business at Rogers State University with a <u>minimum 2.5 GPA</u>. This is a one-year scholarship given in the fall semester to a Cherokee Nation citizen residing in Rogers or Mayes County.

**District 6 & 8 Carl Albert John Lance Kelley Memorial Scholarship** — Applicant must be enrolled at Carl Albert State College in Sallisaw, OK, with a <u>minimum 3.0 GPA</u>. This is a one-year scholarship given in the fall semester to a Cherokee Nation citizen residing in Adair or Sequoyah County.

**Charles Alan Beauchamp Scholarship** — Applicant must be a <u>first-generation</u> undergraduate student majoring in an approved environmental field with a <u>minimum 3.0 GPA</u>. This is a one-year scholarship reserved for Cherokee Nation citizens residing within the Cherokee Nation jurisdictional area.

**Cherokee Nation Businesses Scholarship** — Applicant must be enrolled full time and accepted into a professional, master's or upper level bachelor's program or school with a <u>minimum 3.0 GPA</u>. Approved areas of study include accounting, finance, engineering (biomedical, chemical, mechanical and electrical), corporate law, marketing and mass communications. This is a renewable scholarship available to Cherokee Nation citizens.

Cherokee Nation District 3 Scholarship Fund — Applicant must be a graduate of Sequoyah High School in Tahlequah, OK, with a <u>minimum 2.5 GPA</u>. This is a one-year scholarship given in the fall semester to a Cherokee Nation citizen.

**Cherokee Nation Foundation Scholarship** — Applicant must be enrolled at a junior college, community college or technical school with a <u>minimum 3.0 GPA</u>. This is a one-year scholarship reserved for Cherokee Nation citizens, with preference given to students who participate in CNF programs such as Junior Achievement, NSU ACT Prep Camp, CCPI or ACT Prep classes.

**Harold "Jiggs" Phillips Scholarship** — Applicant must be a graduating high school senior from an Adair County high school (Cave Springs, Stilwell, Watts or Westville) with a <u>minimum 3.0 GPA</u>. Student must enroll in a higher education institution the semester immediately following receipt of award. This is a one-year scholarship reserved for Cherokee Nation citizens.

HP Engineering Inc. Scholarship — Applicant must be an undergraduate or graduate student who has a declared major in an ABET-accredited engineering program and has been accepted as either an electrical or mechanical engineering major. Applicant must have completed at least 60 credit hours or be an enrolled junior, senior, master's or terminal doctorate student. Scholarship requires commitment to participate in a two-day job shadowing experience (one day fall/one day spring) at HP Engineering Inc. offices located in Tulsa, OK, and Rogers, AR. This is a **one-year** scholarship reserved for an enrolled citizen of Cherokee Nation, Eastern Band of Cherokee Indians or United Keetoowah Band.

**Indian Women's Pocahontas Club Scholarship** — Applicant must be a graduating high school senior or undergraduate student with a <u>minimum 2.5 GPA</u>. This is a one-year scholarship reserved for Cherokee Nation citizens.

**James R. Upton Memorial Scholarship** — Applicant must be a graduating high school senior from Sequoyah High School in Tahlequah, OK, with a <u>minimum 2.0 GPA</u>. Student must enroll in a higher education institution the semester immediately following receipt of award. This is a one-year scholarship reserved for Cherokee Nation citizens.

Kenneth Comer Scholarship — Applicant must be a graduate student with a minimum 3.0 GPA majoring in psychology or counseling psychology who has the intent of becoming a licensed professional counselor or licensed drug and alcohol counselor. This is a one-year scholarship reserved for Cherokee Nation citizens attending Northeastern State University, Oklahoma State University or the University of Oklahoma. If enrolled at the University of Oklahoma, student has the opportunity to serve as an intern at the Oklahoma Association for Problem and Compulsive Gambling (OAPCG) office in Norman. OAPCG will pay for the certification of Problem Gambling Counselor.

Oklahoma State University/Cherokee Nation Foundation Scholarship — Applicant must be a current, full-time student or be a graduating high school senior accepted to the university. This award is reserved for Cherokee Nation citizens and is renewable for up to five years. Student must <u>maintain a 3.0 GPA</u>, stay in good standing with the university and pursue only one degree. A letter of reference is required for consideration.

**Peruzzi Family Scholarship** — Applicant must be a graduating high school senior with a <u>minimum 3.0 GPA</u> and enroll full time in a four-year, postsecondary institution. This is a one-year scholarship reserved for Cherokee Nation citizens residing within the Cherokee Nation jurisdictional area.

**Sequoyah High School Alumni Scholarship** — Applicant must be a graduating high school senior from Sequoyah High School in Tahlequah, OK, and have a <u>minimum 2.5 GPA</u>. Student must enroll in a higher education institution the semester immediately following receipt of award. This is a one-year scholarship reserved for Cherokee Nation citizens.

Senior Master Sargent Texie C. Taylor, USAF Memorial Scholarship — Applicant must be an undergraduate or graduate student majoring in physics, chemistry, biology, medicine, nursing (RN), engineering (aerospace, civil, chemical, electrical, mechanical) or mathematics with a minimum 3.0 GPA. This is a one-year scholarship reserved for Cherokee Nation citizens residing within the Cherokee Nation jurisdictional area.

**Susan B. Agnew Leoser Scholarship** — Applicant must be a graduating high school senior or undergraduate student with a <u>minimum 2.0 GPA</u>. This is a one-year scholarship reserved for Cherokee Nation citizens residing outside the Cherokee Nation jurisdictional area and attending a junior college, community college or technical school. Preference is given to students who show a history of volunteer service.

University of Tulsa/Cherokee Nation Foundation Scholarship — Applicant must be a current, full-time student or be a graduating high school senior accepted to the university. This award is reserved for Cherokee Nation citizens and is renewable for up to five years. Student must <u>maintain a 3.0 GPA</u>, stay in good standing with the university and pursue only one degree. A letter of reference is required for consideration.
