Education Committee Career Services February Monthly Report Diane Kelley, Executive Director

Alternative Education had five students pass all components of the HSE (GED®, HiSET®) Test during the month of January. Our total graduate count is 15.

The Career Skills Education Classes had 77 individuals complete.

The NHEDWG (Opioid) Grant (HOPE) program is continuing to grow and meet the needs of individuals affect by the Opioid Crisis. We have had program participants on work experience in various locations and this has ultimately resulted in the individuals being hired full-time. The uniqueness of the individuals we assist is in having a variation of barriers they are dealing with. Our goal is to assist individuals with overcoming their own unique barrier(s). The Participant Success Story below is from one of our many successful program participants.

HOPE Participant Success:



Aelicia Green, Tahlequah native and Cherokee citizen, was a successful participant in the Helping Others Perform Effectively (H.O.P.E.) Program, offered through Cherokee Nation Career Services. This program is funded through a grant from the Department of Labor and assists individuals who have had their lives adversely affected by the opioid crisis.

"I work fulltime as a Clerk II in the Behavioral Health Department at Hastings Hospital in Tahlequah," said Green. I'm so grateful to Career Services for everything they helped me with but it was a long road to get here." Green grew up in Tahlequah, but started getting into trouble at an early age. "I made some really bad choices early in life," said Green. "I was sixteen when I started dating a man that was much older than me and dropped out of school after I got pregnant. I was way

too young to be making those kinds of choices." At that time, home schooling was not an option, neither was the choice to bring your child to school. "I was embarrassed and worried about how I would be treated by the other kids and teachers," said Green. "I dropped out of school and started working."

Green became pregnant again at nineteen but after she had the baby her life took a turn for the worse. "I started doing some bad things," said Green. "I was involved in a very violent relationship, some extreme domestic violence issues, and I started using drugs. I was hanging out with the wrong people, wasn't working, and all I did was live off of my mom and do drugs." This cycle continued until eventually Green was arrested and charged with drug possession. "I went to county jail for a short time but eventually went to prison, said Green." "This all sounds crazy when you say it out loud, but going to prison was probably the best thing that ever happened to me at that point in my life. I did a lot of growing up during the time I spent in prison."

Green was released from prison and sent to a half-way house for nearly six months. "After I was released from the halfway house I moved back to Tahlequah and lived at my mom's house," said Green. "I was scared and confused about how to get over this addiction thing so I could move on with my life but it all turned around when I gave my life to the Lord." Green has great support at the church she attends. "The ladies at church help me stay away from all the thugs and the drugs," Green said. "The people there are the best support system I could ever ask for." Green visited Career services and enrolled in the H.O.P.E program which led to her finding employment at Hastings Hospital. "I'm just truly



grateful for the opportunity Career Services has given me," said Green. I have a job with full benefits and next year will qualify for the Christmas bonus."

The **Trade and Economic Transition** grant program is now officially under Public Law 102-477. In addition, the grant team has been given guidance to continue working with the same eligibility, while the area of operation has extended west all the way to Oklahoma City. Applications and intakes have greatly increased and likewise eligible participant numbers have gone from 75 last quarter end to 120 this month. The upward trend has greatly increased the workload of the three Career Specialists on the program. However, several interview panels are completed, and a new group of Career Specialists that will operate under the grant should begin to show up in Career Services offices throughout the jurisdiction, including Tahlequah, Tulsa, Pryor, Muskogee, and Sallisaw.

Larry Daugherty, Job and Business Developer for the **Tribal Economic** team, and Joshua Drywater, **TET** program manager, attended a job fair around the Oklahoma City area that focused on providing assistance for a large group of workers who had been laid off from Halliburton. The event was a huge networking opportunity for the team, which has not operated in the area before. Several follow up meetings with unions, businesses, and workforce partners have continued since the event.

The **Trade and Economic Transition** team has also increased efforts into the Washington county area. Tonya Foreman, Tri-County Technology Center representative, welcomed members of the team and allowed knowledge of the grant to be relayed to students in their training programs. From there, applicants were allowed to visit with Career Services members on location. The school was instrumental in providing grant information to members of their community who had not heard of the grant through other outreach methods. Future plans to work with Tri-County Technology in the upcoming semesters have already been confirmed, and a partnership in helping individuals within the community transition into new careers will greatly benefit the Bartlesville area.

Lastly, the team utilized a small lull in client flow during the holiday season by participating in training events focusing on the questions presented by Career Specialists on current files and a brief overview of the operations of Public Law 102-477. During the transition of funding sources, administrative efforts were also focused on that ensured all client files were up-to-date to make the transition as seamless as possible. 2020 is the last year of the grant funding and

eligibility that the TET team has learned to embrace. The team highly expects a very productive and busy year helping the dislocated workers in the eastern half of Oklahoma find sustainable, unsubsidized employment.

Vocational Program Participant Success:



Tiffany Thompson completed the Physical Therapy Assistant Program with ICTC-Muskogee and Connors State College. Tiffany obtained her Physical Therapy License and secured employment in her area of training with a local physical therapy site here in Tahlequah.

Tiffany Thompson's days in school and training were not without some challenges, mostly financial. But through applying with Career Services PL 102-477 Vocational program, Tiffany was able to get the financial assistance she needed to complete her education and training. Tiffany began her education after graduating from Hulbert High School, going on to Connor's State College and then to ICTC-Muskogee.

She was long-term unemployed and was dependent on financial aid, public assistance and others to meet her basic needs while pursuing a career in Physical Therapy Assisting. Through Career Services PL 102-477 Vocational Program she was able to get assistance with tuition, books, fees, and supportive services for uniforms needed for her clinical and the expense of the Physical Therapy Assistance exam, application and licensing fees. Since then she has become a fulltime employee with Redbud Physical Therapy in Tahlequah.
