#### STATE OF THE NATION

Principal Chief Chad Smith requested a moment of silence to recognize the following friends and loved ones who have passed on the last month. Veteran's honored this month were Jerry Woods, Anna Marie Wallce, and Brad Carson. Indian Child Welfare had more than 1600 angels on the tree this year. CN and CNE employees adopted 1200 angels and to help bridge the gap Cherokee Nation also donated more than \$25,000 dollars to defray costs so the remaining angels can have a joyous Christmas. Nancy John, Environmental employee received the Jan Stephens Award for EPA Excellence. Brenda Fitzgerald and Alisha Banks, employees of the Vocational Rehab Program also received National recognition from the Consortium of Administrators for Native American Rehabilitation due to their work to improve the quality of life for American Indians with disabilities. In National news the Cobell Class Action Suit filed over alledged mismanagement of individual Indian money accounts has reached a settlement that will affect some citizens but that settlement has not yet been approved by the court or Congress. For the latest information a person can contact the Corbell Lawsuit Hotline at 1-800-961-6109. The impact of Cherokee citizens is still a question at this time. Updates received will be posted on the internet. December 11th Cherokee Nation closed on the purchase of Blue Ribbon Downs Racetrack property in Sallisaw. The property includes 100 acres that is situated within tribal boundaries. This was a real estate purchase and not a horse track purchase and to date Cherokee Nation has not made a determination as to the use of the property. Wednesday at 2:00 p.m. the Cherokee Nation Immersion School will perform a Christmas Program for their families at the old Sequoyah High School gymnasium. Cherokee Nation employees will celebrate Christmas Friday afternoon at the "Place Where They Play" and the program starts at 1:00 p.m. Sequoyah Schools is hosting their annual Christmas Luncheon Thursday, December 17th from 11:00 to 1:00 p.m. The Cherokee Nation Youth Choir will be performing in Wagoner. Job Corp is hosting their American Indian Chamber of Commerce Luncheon tomorrow at 12:00 p.m. in the Job Corp cafeteria.

**COMMITTEE REPORTS** 

Monthly Reports:

Housing Authority - David Southerland

David Southerland announced the December Housing Authority Board meeting is scheduled for December 12th at 5:30 p.m. in the Alyene Hogner Conference room. The main topic will be revisions in the Community Shield Programs deductible amount. The current deductible is \$250.00 and the current annual premium is

\$370.00 for a framed home and \$465.00 on a mobile home. There will be a small increase in the annual premium and the recommendations to the board will be to raise the deductible to \$500 and this years premiun increase will be \$35.00 per year. The changes are necessary due to high incident of claims on the program and they want to get it manageable and profitable. The homes and apartments owned by the Housing Authority have had a substantial increase in claims over the last three years and the major concern is the number of fire losses. Amerand will be working with Housing Authority staff to decrease those claims with community meetings and things of that nature.

#### Cherokee Nation Entertainment - David Stewart

David Stewart reported September 2009 results were substantially better than September 2008 results. CNE employees bought almost 500 individual angels this year on their own behalf. CNE contributed \$20,000 to assist in purchasing gifts for those who did not have angels. CNE employees went to Eucha to work with Mr. Soap on the Eucha community building on Saturday morning and this is an initiative that CNE will continue to sponsor from here forward. Save America's Treasures awarded Cultural Tourism \$150,000 grant to restore the Capital Building. The Supreme Court Exhibit Building Design is being installed. With regard to construction, the event center is on schedule to open in September of next year and the hotel is under construction and on schedule. David Stewart recognized CNE employees, Tonya Rue and Roger Barr.

#### Cherokee Nation Business, Inc - David Stewart

David Stewart reported closed the year with their subsidiaries which inlcude: the newest one, CSG and the other two APSE and CCRC which is in the construction business. CSG has been closed for about a month but the operations of these three companies generated almost \$1 million dollars in profit for the Nation last year. They all have come into the year with good backlog and good management in place. CSG CEO's presented their annual business plans at the last board meeting and he is happy to say they really have some good business sense and good platforms.

#### Cherokee Nation Industries - Bryan Collins

Bryan Collins reported the November financials are still pending completion but they are running ahead of budget in October based on revenue of October being \$8.9 million with a profit of \$165,000 and continued backlog building for 2010. Local employment is 458 with 82% Native American and from a stand point of what is going on for 2010 they see this number increasing based on the backlog. CNI employees participated in the Stilwell, Tahlequah, and Kelleyville Christmas parades, angel tree program, and the Oaks Mission program. Verizon's contract is in place and they are starting to perform on that contract. The AT&T Contract since October has expanded shipping to 41 states and exporting for AT&T. They feel there will be substantial increases in the telecommunications. In 2010 they will see a full National platform as well as exporting in the legacy T product line. In Aerospace, Bell Helicopter has doubled their backlog for 2010 and they are currently in the process of determining how many employees, training, space, and tables they will be needing. L3 has additions of new orders from the Army for tactical generators for 2010 as well. CEI awarded a multi-year, multi-million contract, which is an extension for another two to three years. Their newest customer out of Huntsville. Security Administrative Management Direct (SAMD). SAMD is responsible for all of the foreign military sales to our allies and CNI is now an official customer and they will be working definitizing what their scope of work will be in supporting their parent product around the world. The next CNI Board meeting is scheduled for January 25th, 2010 at 2:00 p.m. with

the location to be determined.
