WHEREAS, the Housing Authority of the Cherokee Nation was created and authorized by Section 1057 of Title 63 of the Oklahoma Statutes;

WHEREAS, the Principal Chief is authorized to select the members of the Commission subject to majority vote of the Council of the Cherokee Nation;

WHEREAS, Candle Melton is hereby nominated for appointment as authorized by the Bylaws of the Housing Authority of the Cherokee Nation and Section 1058 of Title 63 of the Oklahoma Statutes; and

WHEREAS, Candle Melton is duly qualified to fill this position pursuant to the Bylaws of the Housing Authority of the Cherokee Nation.

BE IT RESOLVED BY THE CHEROKEE NATION, that Candle Melton is hereby confirmed as a Commissioner of the Housing Authority of the Cherokee Nation as authorized by the Bylaws of the Housing Authority of the Cherokee Nation and Section 1058 of Title 63 of the Oklahoma Statutes for a term of 3 (three) years beginning October 30, 2021 until October 30, 2024.
