WHEREAS, the Principal Chief is authorized by Title 68 §12 to select the members of the Commission subject to majority vote of the Council of the Cherokee Nation;

**WHEREAS,** Fan Robinson is duly qualified to fill this position pursuant to the laws of the Cherokee Nation and is hereby nominated for reappointment; and,

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Fan Robinson is hereby confirmed as a Commissioner of the Cherokee Nation Tax Commission for a term of three (3) years beginning February 15<sup>th</sup> 2022 and expiring February, 2025.
