**BE IT RESOLVED BY THE CHEROKEE NATION;** the Tribal Council hereby confirms Shaun Shepherd as a member of the Board of Directors of Cherokee Nation Businesses LLC for a term of three (3) years beginning February 28<sup>th</sup> 2022 and expiring February 2025.
