WHEREAS, Barry Reynolds is duly qualified and should be appointed to Seat One (1) on the Board of Director of Cherokee Nation Businesses, LLC and its successors; therefore,

BE IT RESOLVED BY THE CHEROKEE NATION; the Tribal Council hereby confirms Barry Reynolds as a member of the Board of Directors of Cherokee Nation Businesses LLC beginning May 16<sup>th</sup> 2022 and expiring August 31<sup>st</sup> 2024.
