COUNCIL OF THE CHEROKEE NATION

A RESOLUTION CONFIRMING THE APPOINTMENT OF JON MICHAEL MCGRATH II AS A COMMISSIONER OF THE CHEROKEE NATION ENVIRONMENTAL PROTECTION COMMISSION

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Environmental Protection Commission (EPC) was created and authorized by Title 27 Section 101 of the Cherokee Nation Code Annotated (CNCA);

WHEREAS, the EPC works to promote efforts which will prevent or eliminate damage to natural resources and the environment and to enrich the understanding of the ecological systems and natural resources important to the Cherokee Nation through regulating traditional areas of environmental concern;

WHEREAS, the Principal Chief is authorized to select members of the Commission subject to majority vote of the Council of the Cherokee Nation; and

WHEREAS, Jon Michael McGrath II is duly qualified and should be appointed as a Commissioner pursuant to the laws of the Cherokee Nation; therefore,

BE IT RESOLVED BY THE CHEROKEE NATION, that the Council of the Cherokee Nation hereby confirms Jon Michael McGrath II as a Commissioner of the Cherokee Nation Environmental Protection Commission for a term of four (4) years beginning June 6th, 2022 and expiring June 31st 2026.

CERTIFICATION

The foregoing resolution was adopted by the Council of the Cherokee Nation at a duly called meeting on the 6^{th} day of June, 2022, having 15 members present, constituting a quorum, by the vote of 15 yea; 0 nay; 0 abstaining.
