WHEREAS, Cherokee Nation Businesses, LLC is a Wholly-Owned Tribal Limited Liability Company created and authorized under the laws of Cherokee Nation; and

WHEREAS, the Principal Chief is authorized to select the members of the Board of Directors, subject to majority vote of the Council of the Cherokee Nation; and,

WHEREAS, Julie Eddy Rokala is duly qualified and should be appointed to Seat Three (3) on the Board of Director of Cherokee Nation Businesses, LLC and its successors; therefore,

**BE IT RESOLVED BY THE CHEROKEE NATION;** the Tribal Council hereby confirms Julie Eddy Rokala as a member of the Board of Directors of Cherokee Nation Businesses LLC beginning June 6<sup>th</sup> 2022 and expiring August 31<sup>st</sup> 2025.
