WHEREAS, the Cherokee Nation has formed a nonprofit corporation for the promotion of education members of the Cherokee Nation, to provide educational assistance to members of the Cherokee Nation and to promote and preserve the language, culture and history of the Nation;

WHEREAS, the Principal Chief is authorized to select the members of the Board of Directors subject to majority vote of the Council of the Cherokee Nation; and

WHEREAS, PATSIANN NIX SMITH is duly qualified to be reappointed to fill Seat Eight (8), pursuant to the Bylaws of the Cherokee Nation Foundation;

BE IT RESOLVED BY THE CHEROKEE NATION, that PATSIANN NIX SMITH is hereby confirmed as a Board Member of Cherokee Nation Foundation, Seat Eight (8) for the term February 10, 2014 expiring February 10, 2018 as authorized by the Bylaws of Cherokee Nation Foundation.
