Matlock is hereby reappointed as a Commissioner of the Cherokee Nation Environmental Protection Commission, Seat #2, for the term of April 1, 2015 expiring March 31, 2019, as authorized by Title 27 Section 101 (B) of the Cherokee Nation Code Annotated (CNCA).
