## COUNCIL OF THE CHEROKEE NATION

## A RESOLUTION AUTHORIZING THE LOCATION OF THE 2015 ELECTION POLLING PLACES

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people; and,

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and,

WHEREAS, the Cherokee Nation now conducts elections every two years and many activities are conducted, as well as Council approval is needed for certain items; and,

**WHEREAS,** Article 2, Section 61 of the Cherokee Nation Election Code states that "The Election Commission shall establish the location of each precinct subject to approval by Council Resolution."; and,

WHEREAS, the Election Commission of the Cherokee Nation has entered into agreements within the Tribe's 14 county jurisdiction to establish polling places for all districts and a list of the polling places is attached to this resolution; and,

**WHEREAS**, pursuant to the Cherokee Nation Election Code referenced hereinabove, the Council has reviewed the list and hereby approves polling places locations; and therefore,

**BE IT RESOLVED BY THE CHEROKEE NATION that** the Council hereby approves the polling places established by the Cherokee Nation Election Commission, the list of which is attached to this resolution.

## CERTIFICATION
