**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Information Technology Department has the following office equipment in its inventory that has been deemed surplus:

**WHEREAS**, the Cherokee Nation Information Technology Department desires to donate this office equipment in “as- is” condition.






