**BE IT RESOLVED BY THE CHEROKEE NATION**, that Junior Dewayne Littlejohn is hereby appointed as a Member of the Cherokee Nation Administrative Appeals Board, Seat #2, for the term of November 16, 2015 through November 15, 2019, as authorized by 14 CNCA § 1 et seq. & 51 CNCA § et seq.
