## A RESOLUTION AUTHORIZING THE DONATION OF SURPLUS EQUIPMENT TO DELAWARE CO. RURAL WATER DISTRICT # 11

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation desires to assist in providing a source of clean drinking water to our communities;

WHEREAS, the Cherokee Nation assisted Delaware Co. Rural Water District # 11 with the construction of the Leach Waterline project.

WHEREAS, the Cherokee Nation has miscellaneous parts and materials remaining from that project that cannot be used elsewhere namely:

56 – 10" X 1" pipe saddles

56 - 5/8" meter loops

56 - 1" corporation stops

12 - 3" X 1" pipe saddles

WHEREAS, Delaware Co. Rural Water District # 11 is a non-profit rural water district that provides water to the Citizens of Leach, Twin Oaks and Oaks OK,

WHEREAS, Delaware Co. Rural Water District # 11 can utilize these parts and materials for installation of water meters for Cherokee citizens

**BE IT RESOLVED BY THE CHEROKEE NATION,** that the Tribal Council hereby authorizes Cherokee Nation Engineering and Sanitation Facilities Construction Program to donate the surplus equipment to Delaware Co. Rural Water District # 11, namely:

56 – 10" X 1" pipe saddles

56 - 5/8" meter loops

56 - 1" corporation stops

12 - 3" X 1" pipe saddles
