### FY 2017 DOI/NPS Historic Preservation Program Tribal Heritage Grants

#### **Executive Summary:**

- 1. Need: The Cherokee Nation (CN) has a USDOI/NPS Tribal Historic Preservation Office. One of the goals of this office is to assess the "Rose Cottage" site for conservation/protection purposes and then nominate the site for listing on the US National Register of Historic Places. To date, the assessment activities are incomplete.
- 2. **Project:** Perform assessment activities on the CN Rose Cottage property:
  - a. Geo-sensing contract GPR (ground penetrating radar) and magnetometry services
  - b. Archeological activities contract work for archeological surveys
  - c. Historical Records review staff and contract research work with historians and area citizens/
  - d. Budget summary: CN is requesting \$40,000 from USDOI/NPS to conduct this project
- 3. **CN Capabilities/Commitment:** The CN will provide some in-kind service/staff/supervisory support in the amt. of \$15K...but such is not required by the grant.
- 4. **Benefits:** Assessment of the rose Cottage site is both a programmatic requirement of the CN and need for proper long-range CN governmental planning
