WHEREAS, the Environmental Protection Commission was created and authorized by Title 27 Section 101 of the Cherokee Nation Code Annotated (CNCA);

WHEREAS, the Principal Chief is authorized to appoint members of the Commission subject to majority vote of the Council of the Cherokee Nation; and

WHEREAS, Lynna Carson is duly qualified to be reappointed as a Commissioner, pursuant to the laws of the Cherokee Nation;

BE IT RESOLVED BY THE CHEROKEE NATION, that Lynna Carson is hereby reappointed as a Commissioner of the Cherokee Nation Environmental Protection Commission, Seat Three (3), for the term beginning January 15, 2018 and expiring January 15, 2022, as authorized by Title 27 Section 101 (B) of the Cherokee Nation Code Annotated (CNCA).
