WHEREAS, the United Wrestling Entertainment Foundation is located within the Cherokee Nation jurisdictional boundaries, operates on limited funds and the donation of this equipment would benefit them greatly.

**BE IT RESOLVED BY THE CHEROKEE NATION,** that the Tribal Council hereby authorizes Cherokee Nation Vocational Rehabilitation Department to donate this equipment to the United Wrestling Entertainment Foundation in Cherokee County as set out above.
