WHEREAS, the Principal Chief, as representative of the Cherokee Nation is authorized to select the members of the Board of Directors, subject to majority vote of the Council of the Cherokee Nation; and,

WHEREAS, Tommye Sue Bradshaw Wright is duly qualified and should be reappointed to Seat 9 as a member of the Board of Directors of Cherokee Nation Businesses, LLC and its successors.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that Tommye Sue Bradshaw Wright is hereby confirmed as a member of the Board of Directors of Cherokee Nation Businesses, LLC and its successors, filling seat 9 (nine), a term beginning in August 2019 and expiring August 31, 2022.
