**WHEREAS,** the Principal Chief, as representative of the Cherokee Nation is authorized to select the members of the Board of Directors, subject to majority vote of the Council of the Cherokee Nation; and,

**WHEREAS**, Brent Taylor is duly qualified and should be reappointed to Seat 5 as a member of the Board of Directors of Cherokee Nation Businesses, LLC and its successors.

**BE IT RESOLVED BY THE CHEROKEE NATION,** that Brent Taylor is hereby confirmed as a member of the Board of Directors of Cherokee Nation Businesses, LLC and its successors, filling seat 5 (five), a term beginning in December 1, 2020 and expiring December 31, 2023
