WHEREAS, the Principal Chief is authorized by Section 5.E. of LA#3-04 to select the members of the Board subject to confirmation by majority vote of the Council of the Cherokee Nation;

WHEREAS, the term of office of Leticea Stevenson-Pablo expires June 2008 and has been selected to be renominated by the Principal Chief.

BE IT RESOLVED BY THE CHEROKEE NATION, that Leticea Stevenson-Pablo is hereby confirmed as a Governing Board Member of the Cherokee Nation Comprehensive Care Agency for a term of (3) years from June 2008 until June 2011.
