BE IT RESOLVED BY THE CHEROKEE NATION, that Harold Ray "Sam" Hart is hereby confirmed as a Commissioner of the Cherokee Nation Tax Commission for the term of three years effective February 2010 through February 2013 as authorized by Legislative Act 1-90, the Act of February 10, 1990.
