**BE IT RESOLVED BY THE CHEROKEE NATION,** that Dennis Springwater is hereby confirmed as a Commissioner of the Cherokee Nation Gaming Commission for the term of three (3) years from June 2008 until June 2011, as authorized by Section 12, Chapter 2, Title IV of the Cherokee Nation Code Annotated.
