REPORTS:

Cultural Tourism - Molly Jarvis

Mr. Travis Owens reported in the absence of Ms. Jarvis. He reported they are working to raise awareness for Murdered and Missing Indigenous Peoples Month. He provided an update on the Cherokee History Course. Mr. Travis gave a few highlights from the report provided. He offered to answer any questions. Councilor Deere requested an update on Route 66. Community & Cultural Outreach - Kevin Stretch

Mr. Stretch reported they are working toward identifying Cherokee speaking churches. They are having in person cultural meetings once again. He provided an update on their construction projects, solar projects and ribbon cuttings. They are currently working with a number of new organizations. The At Large meeting attendance continues to grow. The CCO Conference is scheduled June 23-24. Mr. Stretch provided an update on the Summer College Student Volunteer Program.
