CALL TO ORDER

Chair Hoskin Jr. called the meeting to order at 1:10 p.m.

INVOCATION

Councilor Snell gave the invocation.

ROLL CALL

APPROVAL OF MINUTES

Councilor Hargis moved to approve the June 28th regular session minutes. Councilor Anglen seconded the motion. The motion carried.

REPORTS:

Marshal Service - Shannon Buhl

Mr. Buhl offered to answer questions from the report provided.

Office of the Attorney General - Todd Hembree

Mr. Hembree provided an update on the Freedman and United Keetoowah Cases as well as the seventy-six acres.

Codification - Todd Hembree

Mr. Hembree stated he has met with Treasurer Horn and funds have been identified for the codification project. The Cherokee Nation Supreme Court has requested to meet and address some issues they have with codification.

Office of the Attorney General - Todd Hembree

Mr. Hembree reported they were successful in the contract support cost litigation. He announced the Cherokee Nation was successful in the defense of the adoption in the South Carolina Case. This is not only a victory for the father and daughter but a major victory for the enforcement of Indian Child Welfare nationwide. Councilor Frailey inquired about the status of the draft amendments the Five Tribes were considering on probates on restricted land. Councilor Cowan Watts requested the opinion in the adoption case be provided to the Council and inquired if it would be available on the web. Councilor Walkingstick inquired about the status of the sick leave policy changes.

Election Commission - Bill W. Horton

Mr. Horton introduced the Election Commission's attorney, Harvey Chaffin. He announced the omnibus report has been provided. He offered to answer questions from the reports provided. Councilor Cowan Watts asked questions regarding consultations within the omnibus report, the voter red cards, media in the precincts, absentee balloting, the status of an election service provider, bad address lists being placed in the phoenix, and auto registering citizens at the age of 18. Councilor Lay inquired about the possibility of the Cherokee Nation performing our own elections. Chair Hoskin Jr. inquired about the Commissions position on presenting an ID when at the polls.

Tax Commission - Sharon Swepston

Ms. Swepston offered to answer questions from the report provided.

Self-Governance - Vickie Hanvey

Ms. Hanvey reported all of the Recovery Act reports have been completed. She stated she attended a meeting with Dr. Charles Grim, The VA, IHS and several other Oklahoma tribes regarding a memorandum of agreement to better serve our Veterans. She provided an update on contract health support cost. She announced they are in the process of hiring staff within self-governance.

Gaming Commission - Jamie Hummingbird

Ms. Debra Wilson reported in the absence of *Mr.* Hummingbird. She offered to answer questions from the report provided and gave an update on their APA compliance. She provided an update on the Gaming Commission's role in the three casino construction projects.

Registrar Citizenship Data Update - David Justice

Mr. Justice provided registration updates for the month of June.

AMEND THE AGENDA

19-00, 08-01 and 05-05, establishing a free and independent press for the Cherokee Nation, sponsored by herself, and Councilors Fishinghawk and Fullbright, 4) An act amending legislative Act 26-12; revising title 26 "Elections" of the Cherokee Nation annotated; amending § 5, adding provisions for apportionment; and declaring an emergency, sponsored by herself and Councilors Fishinghawk and Hoskin Jr., 5) A legislative act repealing all sections of title 28 containing all sections regarding nepotism and ethics and enacting a replacement thereof, sponsored by herself and Councilors Fishinghawk seconded the motion. Councilor Coates called for division.

The motion to amend the agenda to include an act to require certain tribal positions of authority to be enrolled citizens of the Cherokee Nation, sponsored by Councilor Lay carried with Councilor Keener opposed. This will be new business 5.

The motion to amend the agenda to include an act to provide for additional oversight to Cherokee Nation Business by the Cherokee Nation Tribal Council, sponsored by Councilor Thornton carried with Councilor Keener opposed. This will be new business 6.

The motion to amend the agenda to include an act amending legislative act 16-09 as amended by legislative acts 19-00, 08-01 and 05-05, establishing a free and independent press for the Cherokee Nation, sponsored by herself, and Councilors Fishinghawk and Fullbright failed by not reaching a two-thirds vote as follows:

Councilor Glory-Jordan requested a special Rules meeting be scheduled for consideration of the items that didn't make the agenda today.

OLD BUSINESS

1. 12-055

AN ACT AMENDING TITLE 13 SECTION 102 (a) and SECTIONS 304 (A)(b) and (c) OF THE CHEROKEE CODE ANNOTATED AND AMENDING LEGISLATIVE ACT 13-07 OF THE CHEROKEE NATION ADMINISTRATIVE PROCEDURE ACT

Councilor Cowan Watts requested clarification that when this item was tabled last month there was a motion to include the Housing Authority. She requested an update from Mr. Morton regarding the conflict.

After some debate was held Councilor Keener moved to table. Councilor Cowan Watts seconded the motion. The motion failed with the following roll call vote:

Councilor Glory-Jordan made a motion to remove the Election Commission from this Act. Councilor Fullbright seconded the motion. After some discussion was held the motion carried with the following roll call vote:

2. <u>12-086</u> AN ACT AMENDING LEGISLATIVE ACT 03-09 AND TITLE 68 CHAPTER 3 OF THE CHEROKEE NATION CODE ANNOTATED - SALES TAX; ADDING EXEMPTIONS FOR ONE HUNDRED PERCENT (100%) PERMANENTLY DISABLED VETERANS AND FOR ALL VETERANS WHO ARE CITIZENS OF THE CHEROKEE NATION

> Councilor Fishinghawk moved to approve. Councilor Byrd seconded the motion. Councilor Frailey offered a friendly amendment to strike Oklahoma National Guard to read National Guard. The friendly amendment was accepted. After additional discussion was held Councilor Cowan Watts voiced concerns with paragraph C.

Councilor Glory-Jordan moved to table. Councilor Hargis seconded the motion. The motion carried.

3. <u>TMP-212</u> DISCUSSION AND POSSIBLE ACTION CONCERNING CHEROKEE NATION HOME HEALTH SERVICE

Councilor Lay moved to table. Councilor Byrd seconded the motion. The motion carried.

1. <u>12-095</u> A RESOLUTION CONFIRMING THE NOMINATION OF STEVE WILSON AS A BOARD MEMBER OF THE CHEROKEE NATION TAX COMMISSION BOARD OF DIRECTORS

> Councilor Hargis moved to approve. Councilor Byrd seconded the motion. After a few questions the motion to approve carried with one in opposition.

2. <u>12-096</u> A RESOLUTION CONFIRMING THE NOMINATION OF RUTH ANN WEAVER AS A COMMISSIONER OF THE CHEROKEE NATION GAMING COMMISSION

Councilor Glory-Jordan moved to approve. Councilor Hargis seconded the motion. After a few questions the motion to approve carried with the following roll call vote:

- 3. <u>12-097</u> AN ACT AMENDING LA#13-07 CHEROKEE ADMINISTRATIVE PROCEDURES ACT

Councilor Glory-Jordan moved to table. Councilor Byrd seconded the motion. The motion carried with some opposition.

4. TMP-214 DISCUSSION: COMPLIANCE WITH ADMINISTRATIVE PROCEDURES ACT BY CHEROKEE NATION ELECTION COMMISSION, ENVIRONMENTAL PROTECTION COMMISSION, GAMING COMMISSION, AND TAX COMMISSION Councilor Cowan Watts commented our Constitution speaks clearly and all of these agencies, regardless if they are moved now or in the future, they are past the deadline for being compliant. Chair Hoskin Jr. requested each department included in the current Act to report on their compliance with the Act. Mr. Harvey Chaffin the attorney for the Election Commission stated he would review the Commissions compliance and submit a report. Mr. Elkins provided a report for the Environmental Protection Commission. Ms. Debra Wilson of the Gaming Commission provided an update to their compliance since their last report. Ms. Sharon Swepston gave a report on the Tax Commissions compliance.

5. <u>12-103</u> AN ACT TO REQUIRE CERTAIN TRIBAL POSITIONS OF AUTHORITY TO BE ENROLLED CITIZENS OF THE CHEROKEE NATION

Councilor Lay moved to approve. Councilor Cowan Watts seconded the motion. After discussion was held Councilor Walkingstick offered a friendly amendment to include the CEO of Cherokee Nation Businesses. The friendly amendment was accepted.

After a lengthy discussion and debate was held the motion to approve carried with the following roll call vote:

Councilor Thornton moved to approve. Councilor Fishinghawk seconded the motion. Councilor Garvin offered a friendly amendment to add the right to terminate the contract. The friendly amendment was not accepted. Councilor Thornton requested the Chair create a subcommittee to create the procedures as shareholders and to review the Cherokee Nation Corporate Act.

After some discussion was held the motion to approve failed with the following roll call vote:
