CALL TO ORDER

Chair Lay called the meeting to order at 2:17 p.m.

INVOCATION

Councilor Snell gave the invocation.

APPROVAL OF MINUTES

Councilor Baker moved to approve the July 16th regular session minutes. Councilor Garvin seconded the motion. The motion carried.

REPORTS:

1. Human Services Department - Marsha Lamb

Ms. Kara Whitworth reported in the absence of Ms. Lamb. Ms. Whitworth recognized Michelle Locust the coordinator of the clothing voucher program. She introduced their new Deputy Executive Director of Human Services, Barbara Foreman. She provided an update on the Elders in Need program. Councilor Thornton inquired what it would take for the elders to receive additional food from the food distribution program. Councilor Garvin inquired about the National Conference on Aging. Councilor Keener inquired about the status of the food distribution center in Collinsville. Councilor Fishinghawk requested clarification on information she was given by the former Chief a couple of years ago that elders were eligible for donated foods if they were on fixed income even if they were over income. Councilor Garvin inquired about the status of the LIHEAP blankets. Ms. Brandy Lemley the Lead Coordinator of the Angel Tree provided a booklet of details pertaining to the program, she provided a brief overview of the program and introduced the workers.

3. Housing Services - David Southerland

Mr. Southerland gave the disclosures for the month.

2. Community Services - David Southerland

He provided an update on the Community Youth grant, Sports team grant, and livestock grant. He announced he would be leaving the tribe at the end of the month. Councilor Thornton disclosed he doesn't have any family working for a contractor of the Housing Authority. He requested assistance for the residents of Braggs with their water issues.

4. Roads & Transportation - Michael Lynn

Mr. Lynn provided a handout of the current active projects. He announced a pre-construction community meeting was held for the Twin Oaks/Bull Hollow project last Thursday with a good turnout. Several questions were asked and concerns were voiced in regard to the handout of active road projects. Councilor Fishinghawk requested a breakdown of how much each subcontractor receives. Councilor Glory-Jordan suggested forming a subcommittee or a work group to review all of the subcontracts for roads projects to determine why non-TERO vendors are being approved. Councilor Hoskin Jr. suggested the Chair review and see if a subcommittee is warranted. Mr. Lynn commented they have some draft contract language currently being reviewed by the Attorney General's office and offered to share with this committee for review prior to the formation of a subcommittee.
