TMP-039 RECOMMENDATIONS FOR POLITICAL CONTRIBUTIONS

Chair Hoskin Jr. stated a multi-page document of federal candidates has been provided along with a single page of state race candidates. Councilor Glory-Jordan moved to approve. Councilor Hargis seconded the motion. The Councilors requested a copy of the questionnaire sent to the candidates. Councilor Glory-Jordan made a motion to add Bob Sears of Bartlesville for \$1,000 not contingent on the questionnaire and to remove the requirement for the questionnaire on Mark Wayne Mullin. Councilor Hargis seconded the motion. Councilor Cowan Watts inquired about the balances and totals given to democrats and republicans. She also inquired about funds paid by the Cherokee Nation for the trip to Martha's Vineyard, the Washington D.C. trip the following week and to the Democratic National Convention for all Cherokee Nation representatives. The amendment carried with some opposition.
