#### STATE OF THE NATION

Bill John Baker Principal Chief

> Chief Bill John Baker recognized both the boys and girls basketball teams at Sequoyah where they both made it to the State Championship Tournament. He announced the Violence Against Women Act Reauthorization was signed by President Obama. He provided an update on the effects of the Federal sequestration to the Cherokee Nation. The Baby Veronica case will be heard in the U.S. Supreme Court and is of critical importance all across Indian Country. The Cherokee Nation Supreme Court held that the fifteen Tribal Council voting districts is Constitutional . CNB continues to set records with a net income increase of twenty-three percent while the dividends to the Nation also increased by ninety percent. The Cherokee Phoenix has turned one hundred and eighty five years old. The Cherokee Marshals participated in the Polar Plunge again this year and raised nearly \$3,000 for the Special Olympics. Chief Baker stated the outreach meetings in Arkansas have been a resounding success. He requested a moment of silence to remember those Cherokee friends and loved ones who we have lost over the last month.

#### Housing Authority - Gary Cooper

*Mr.* Cooper announced the next board meeting will be held on the 19th at 5:30 p.m. They received notice from HUD of the suspension of the 184 Loan Guarantee Program. They continue to monitor the sequestration and how it affects NAHASDA very closely. He provided an update on the new home construction program and announced they have started construction on ten more new homes. He provided an update on the Community Shield Insurance Program stating there will be a small rate increase.

#### Cherokee Nation Business, LLC - Shawn Slaton

Mr. Slaton announced they have closed their first quarter very strongly with December profits up 40% over budget. He reported they have recently opened the second tower at Hard Rock. The Bassmaster Classic was a very successful event. He provided an update on the employee volunteer activities. They changed the name of Cherry Springs Golf Club to Cherokee Springs Golf Club and making some other updates there on the facility. Their marketing department won an award from the Tulsa Chapter of the American Advertising Confederation for creative technology for their digital library. The Cherokee percentage of employment at the end of January was 72.6% with 7.3% other Native American and a total Native American employment percentage of 79.9%. Speaker Glory-Jordan stated they continue to work on the council policies and may form a work group. Councilor Cowan Watts requested clarification on the purchase of the Berry properties. She also inquired if there had been any other purchases. Councilor Fullbright inquired as to the status of the feasibility study in Sequoyah County. Speaker Glory-Jordan stated she would form a work group and asked Councilors Garvin, Fullbright, Hoskin Jr., and Thornton along with her to work with CNB to form the policies.
