Chair Byrd called the meeting to order at 1:17 p.m.

Councilor Snell gave the invocation.

OLD BUSINESS

1. 13-123 A RESOLUTION CONFIRMING THE REAPPOINTMENT OF COLEMAN BARTOW FITE AS A DISTRICT JUDGE OF THE CHEROKEE NATION DISTRICT COURT

Councilor Glory Jordan moved to approve. Councilor Walkingstick seconded the motion. Judge Fite wasn't available for questions. The motion to approve carried.

2. 13-137 AN ACT AMENDING THE CHEROKEE NATION GAMING COMMISSION ACT, SETTING REQUIREMENTS AND DECLARING AN EMERGENCY

Councilor Baker requested the minimum wage legislation be placed back on the agenda next month as the ninety day table has expired.

Councilor Fishinghawk moved to table for thirty days. Councilor Thornton seconded the motion. The motion carried.

NEW BUSINESS

1. 14-001 A RESOLUTION CONFIRMING THE REAPPOINTMENT OF PATSIANN NIX SMITH AS A BOARD MEMBER OF THE CHEROKEE NATION FOUNDATION

Councilor Glory Jordan moved to approve and commented Ms. Smith isn't present today but was available not too long ago when she was appointed to complete someone else's term. Councilor Walkingstick seconded the motion. Councilors Walkingstick, Fullbright, Vazquez and Fishinghawk requested to be added as sponsors. The motion to approve carried.

2. 14-002 A RESOLUTION CONFIRMING THE REAPPOINTMENT OF SHANNON FISHER AS COMMISSIONER OF THE CHEROKEE NATION GAMING COMMISSION

Councilor Fullbright moved to approve. Councilor Thornton seconded the motion. All Councilors requested to be added as sponsors. After discussion was held the motion to approve carried.

3. 14-003 A RESOLUTION ELECTING THE OFFICE OF SECRETARY OF THE TRIBAL COUNCIL

Councilor Glory Jordan moved to reappoint our current Secretary Councilor Fishinghawk. Councilor Fullbright seconded the motion. The motion carried with Councilor Coates abstaining.

4. <u>14-007</u>

A RESOLUTION RATIFYING IMPLEMENTATION AGREEMENT # 2 (IMPLEMENTING 2008 MEMORANDUM OF AGREEMENT AS TO NAHASDA FUNDING FOR DELAWARE FORMULA CURRENT ASSISTED STOCK) BETWEEN THE CHEROKEE NATION AND THE DELAWARE TRIBE OF INDIANS

Councilor Lay moved to approve. Councilor Walkingstick seconded the motion. Discussion was held and a friendly amendment was accepted to insert the implementation date of April 1, 2014 and to correct the title. Once discussion was exhausted the motion to approve carried

5. 14-004

AN ACT AMENDING LA-46-12 REVISING TITLE 26 ("ELECTIONS") OF THE CHEROKEE NATION CODE ANNOTATED

Councilor Glory Jordan moved to approve stating these amendments would make out law consistent with our Constitution and how the Election Commission does their business. Councilor Fishinghawk seconded the motion. Councilor Lay voiced concern for TERO protection. Councilor Glory Jordan offered language for a friendly amendment addressing Councilor Lay's concerns by including policies for TERO. The language would be included in Chapter 2 § 11 "within ninety days from adoption of this act the Commission shall adopt tribal preference policies for hiring and contracting". The friendly was accepted. Councilor Keener offered a friendly amendment to change "membership" to "citizenship". The friendly was accepted.

After numerous questions were asked Councilor Cowan Watts made a motion to restore the original language in #8 of page 6. Councilor Keener seconded the motion. Councilor Lay requested a definitive time period. He offered a friendly amendment of inserting language of "at least forty-five days in advance of the election" following the new language "posted after their selection". The friendly was not accepted by Councilor Cowan Watts.

Councilor Cowan Watts motion to restore the language in Chapter 2 § 11 C8 failed by the following roll call vote:

Nay: 9 - Jodie Fishinghawk; Tina Glory Jordan; Janelle Fullbright; David Walkingstick; Joe Byrd; Curtis Snell; Janees Taylor; David Thornton, Sr. and Victoria Vazquez

Abstain: 1 - Dick Lay

Councilor Lay offered his friendly amendment once again to insert language of "at least forty-five days in advance of the election" following the new language "posted after their selection" in Chapter 2 § 11 C8. The friendly amendment was accepted. Councilor Baker suggested inserting Councilor Lay's friendly following "Approve the number and location of precincts" for better flow. Councilor Lay accepted the request.

Councilor Cowan Watts requested clarification on Chapter 2 §11 E. After discussion was held Councilor Cowan Watts made a motion to restore the original language in E. Councilor Keener seconded the motion. The motion failed with the following roll call vote:
