A RESOLUTION FOR CHEROKEE NATION EDUCATION DEPARTMENT TO PROVIDE EQUAL PER CAPITA FUNDING TO ALL ELIGIBLE JOHNSON-O'MALLEY STUDENTS AT ALL PUBLIC SCHOOLS WITHIN THE 14 COUNTY JURISDICTION OF THE CHEROKEE NATION FOR THE FY'15 SCHOOL YEAR

Councilor Hargis moved to approve and offered a friendly amendment in the title, the last Whereas and in the Resolved clauses to strike "for" and replace with "commencing with", in the Resolved clause change "with" to "within" and "count" to "county". Councilor Vazquez seconded the motion and accepted the friendly's. Councilor Taylor requested clarification on the Turkey Ford request from last month. After some discussion was held Councilor Glory Jordan offered a friendly amendment to exclude charter schools and private schools. The friendly was accepted. The motion to approve carried.
